Preface

Household Income and Expenditure Survey 2006/07 was conducted by the Department of Census and Statistics under the National Household Sample Survey Program. This survey is the sixth in the series of Income and Expenditure Surveys conducted once in five years period since 1980.

Data collection of this survey was conducted in twelve monthly rounds from July 2006 to June 2007 and the survey was conducted in all the districts in Sri Lanka, excluding the districts in the Northern Province and Trincomalee district. A sample of equal size was enumerated in each month to capture the seasonal variation of the income, the expenditure and the consumption.

This report is the final report, which is based on the twelve months data and gives information on basic demographic characteristics of the household income, expenditure and assets etc. Information in this report will supersede the information given in previous publications related to this survey.

1. Introduction

1.1 History

The Department of Census and Statistics (DCS) under the National Household Survey Programme conducts Household Income and Expenditure Survey (HIES) once in every five years time.

The first survey was done in 1980/81 namely Labour force & Socio- Economic survey and it was continued again in 1985/86. This survey provides comprehensive information on labour force characteristics, income and expenditure patterns and also included background information on demographic characteristics of the household population. In 1990 Socio- Economic Survey was separated into 2 individual surveys.

- (1) Labour Force Survey
- (2) Household Income & Expenditure survey

Therefore Household Income & Expenditure Survey has been continued, since 1990 as a separate survey. This survey provides information on household income and expenditure, to measure the levels and changes in the living condition of the people, to observe the consumption patterns, to compute various other indicators such as poverty etc. Generally 25000 housing units are taken as a sample from whole country for the survey to facilitate the estimates to be given at the district level. The data collection in the field is done in twelve monthly rounds to capture the seasonal variation of income and expenditure patterns of households. The data was collected through direct personal interviews using a schedule, which consisted of three sections as follows.

- (1) Demographic characteristics
- (2) Household expenditure (Food and Non-food items)
- (3) Household income (Monetary and Non-monetary income)

The last survey was the fifth in the series and was conducted during the period from January 2002 to December 2002 in all provinces other than Northern and Eastern provinces in Sri Lanka. In 2005 the survey was planned to be conducted throughout the year but unfortunately some coastal areas in Sri Lanka were hit by Tsunami catastrophe in December 2004, which caused several damages, hence the survey was not conducted. Anyway In 2005, a special small scale household income and expenditure survey was conducted to take into account income and expenditure patterns of the country after Tsunami disaster happened in December 2004. The sample size of this survey was 5000 housing units distributed among all 25 districts in Sri Lanka. Data was collected within three months period from September to November 2005.

HIES 2006/2007 is the sixth in the series and the field work of the survey was done during the period from July 2006 to June 2007 throughout the island excluding Northern province and Trincomalee district in Eastern province. For this survey (HIES 2006/07), the questionnaire was expanded and it consists of 9 sections to collect more

information on poverty. In general the survey gathers information related to demographic characteristics of the members of the household, expenditure on food and non-food items and income received through different sources. Apart from the above topics, the following additional areas are also covered in 2006/07 survey.

- (1) School education (aged 5-20 years)
- (2) Information related to health
- (3) Inventory of durable goods
- (4) Access to facilities in the area
- (5) Debts of the household
- (6) Information about housing
- (7) Agriculture holdings and livestock

1.2 Decentralized data entry

On experimental basis, activities related to data entry and cleaning of HIES 2006/7 were decentralized for six districts from January 2007 to June 2007. Those districts were Gampaha, Kandy, Matale, Matara, Badulla and Ratnapura. Main objective of decentralization of such activities are

1. To improve the quality of the data
2. To minimize the time taken for data entry and cleaning
3. To enhance the knowledge and capabilities of the district statistical staff

(World Bank provided technical support in selection areas for the above decentralization activities of HIES 2006/07.)

1.3 Limitation of data

This report provides the estimated values based on 12 months period from July 2006 to June 2007. (Excludes Northern Province and Trincomalee district in Eastern province) The tables in this report are presented at national level, sectoral level, province level and district level along with comparing with the information and findings of the previous surveys. The results give in this publication will supersede all previous results of the survey so far published.

1.4 Survey methodology

A two stage stratified random sample design was used in the survey. Urban, rural and estate sectors of the district are the domains for stratification. The sample frame is the list of buildings that were prepared for the Census of Population and Housing 2001.

Selection of Primary Sampling Units (PSU's)

Primary sampling units are the census blocks prepared for the Census of Population and Housing - 2001. The sample frame, which is a collection of all census blocks in the domain, was used for the selection of primary sampling units. A sample of 2200 primary sampling units was selected from the sampling frame for the survey. Each selected block was updated to include newly built housing units and exclude demolished housing units, which are no longer to existence. This updating operation was also carried out over a period of 12 months, starting from June 2006 to May 2007. For each PSU, updating was done about one month prior to the scheduled interviewing.

Selection of Secondary Sampling Units (SSU's)

Secondary Sampling Units are the housing units in the selected 2200 primary sampling units (census blocks). From each primary sampling unit 10 housing units (SSU) were selected for the survey. The total sample size of 22000 housing units was selected and distributed among districts in Sri Lanka.

Sample allocation

Allocation of the number of Primary Sampling Units for the districts and sectors were done proportionately to the number of housing units and the standard deviation of the expenditure values reported in the respective domains in the Household Income and Expenditure survey 2002 (Neymann Allocation). The district sample was equally distributed among the 12 monthly rounds. Table 1.1 and Table 1.2 give the sample distributions by district and by sector respectively.

Adjustment for unit non-response

The occurrence of unit non-response was determined by examining the final result code recorded under control data section of the schedule. Based on the final result codes the households were grouped into the following categories, which were used as a basis for adjusting for the unit non-response.

Category 1 and 2

These were considered as fully accounted for as a schedule was completed to the extent required by the situation at the time of interview and therefore no adjustment was necessary.

Category 3

This is incomplete therefore; a non-response adjustment was made for this category. The assumption made here for the adjustment of non-response was the proportion of households in category 3 is the same as the corresponding proportion for sample households in category 1. This assumption is applied on a block-by-block basis separately for urban, rural and estate sectors. The block weight before adjusting for unit non-response was

1.6 Definitions and Concepts

Readers should be aware of the definitions of the survey terms prior to interpreting or comparing the data. The definitions of the terms frequently used in this report are given below.

Household

A household may be a one-person household or a multi-person household. A one-person household is a unit where a person lives by himself and makes separate provision for his food (either cooking the food himself or purchasing). A multi-person household is a group of two or more persons who live together and has a common arrangement for cooking and partaking food. Boarders and servants who share the meals and housing facilities with other members of the household are also considered as members of that household.

Head of the household

Head of a household is a person who usually resides in the household and is acknowledged by the other members of the household as a head.

Urban sector

Area governed by either Municipal Council or Urban Council is considered as Urban Sector.

Estate sector

Plantation areas, which are more than 20 acres of extent and having not less than 10 residential labourers, are considered as estate sector.

Rural sector

Residential areas, which do not belong to urban sector or estate sector, are considered as rural sector.

Marital status

The marital status recorded was the current status at the time of the survey. A person whose marriage was registered is classified as married (registered). If the marriage has not been registered according to the law but the person claimed to be married according to the custom or repute then it is also classified as married (customary).

A person is regarded as divorced only if a divorce has been obtained in a court of law. A person who has obtained a judicial or legal separation in a court of law is classified as separated (legally). On the other hand if a person had been voluntarily

separated without obtaining a court order then such person fall into the same category classified as separated (not legally)

Share of income

Household size

Number of persons usually living in the household including boarders and servants etc. is defined as household size.

Household income deciles

Income deciles are income groups whose boundaries are defined as to get 10 percent of the total number of households fallen into each group.

Household expenditure deciles

Expenditure deciles are defined similarly as income deciles, but expenditure values are used instead of income values.

Gini Co-efficient

Gini Co-efficient of a distribution is defined as the ratio of the area between the diagonal and the Lorenz curve to the triangular region underneath the diagonal.

Income receiver / obtainer

A person who is 10 or more years old and his or her calculated total monthly income received from any source is more than or equal to Rs.150 then he or she is defined as an income receiver/obtainer in this survey.

Food ratio

2. Income

Household income is defined as the income received by all the members of the household from various sources, either in cash (monetary income) or in kind (non-monetary income). The main income sources used in this survey are wages and salaries, income from agricultural activities (seasonal and non seasonal crops), income from non agricultural activities, other cash income (Samurdi, dividends, interests, current remittance and transfers, windfall income etc.) and income in kind (consumed quantities of home grown fruit and vegetables, firewood, estimated rental value of owner occupied housing unit etc.).

Obtaining income information from individuals and households is a difficult task. People do not prefer to give complete and real information on income. Therefore to gather more accurate and reliable data, income information declared by the household members were collected in six separate sections. Apart from that an extra column was added in the expenditure section to gather more information on consumed items such as freely received, home grown products etc. Using this information, average monthly household income (mean income), median income, per capita income, income receiver's income, Gini coefficient of household income etc. were estimated.

2.1 Household income

According to Table 2.1 the survey results reveal that the mean household income per month for Sri Lanka is Rs. 26286 in 2006/07. The highest mean income per month is reported from urban sector (Rs. 41928), Western province (Rs. 34282) and Colombo district (Rs. 42825), which compared to other sectors, provinces and districts respectively. It also shows that the lowest household income is reported from estate sector among all other sectors and Sabaragamuwa province shows the lowest household income compared to the other provinces.

Median household income is a better indicator than the mean household income to compare the household income in Sri Lanka. The survey results reveal the median household income per month for Sri Lanka is Rs. 16735, which means half of the households in Sri Lanka have received less than Rs. 16735 per month per household in the year 2006/07. District variation of median household income shows that half of the numbers of households in Colombo district receive less than Rs. 24711 per month, while half of the number of households in Nuwara Eliya district receives less than Rs. 11914 per month per household. The values of median income of all provinces, other than Western province and Southern province are less than, that of the national level figure of Rs.16735.

Figure 2.1: Mean household income and median household income by sector - 2006/07

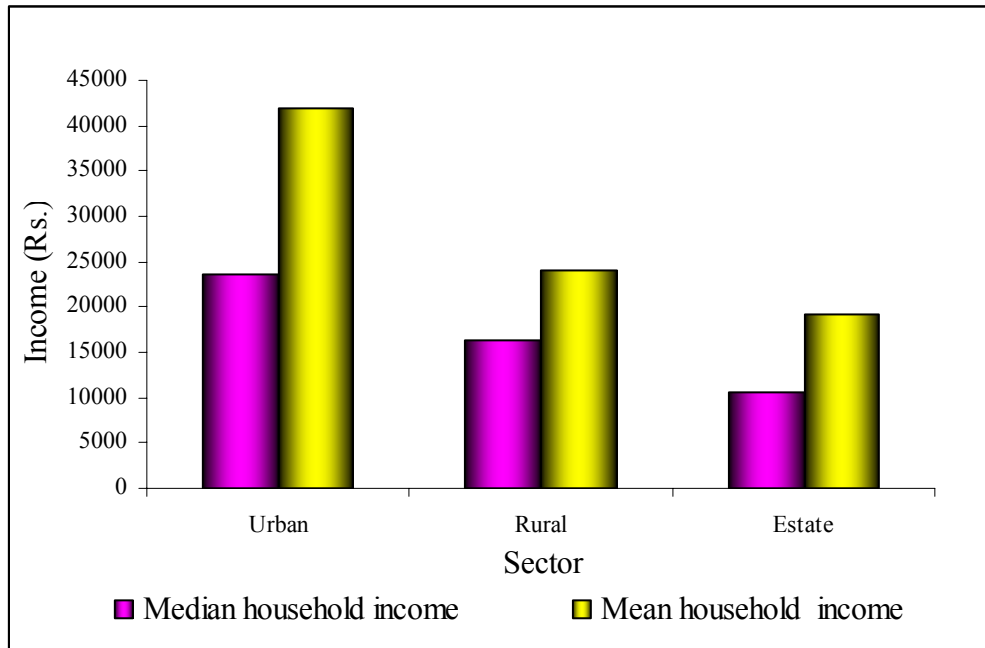


Figure 2.2: Median and mean household income by province – 2006/07

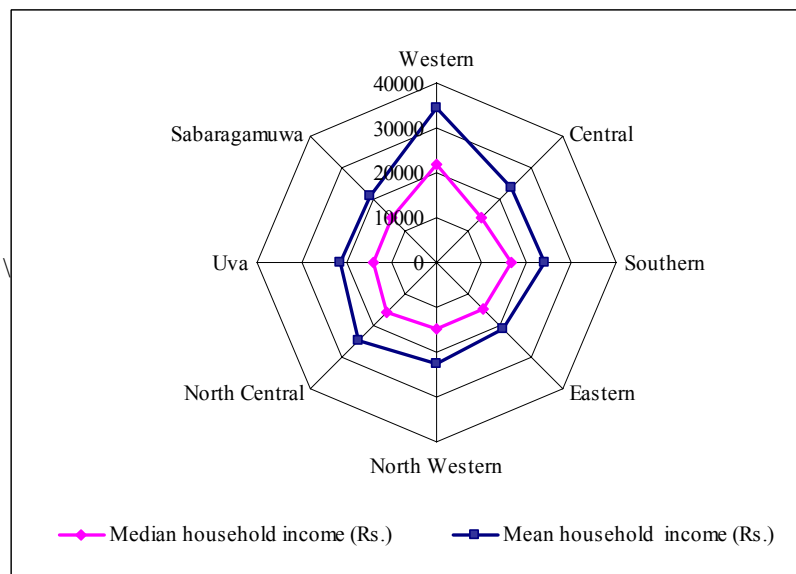
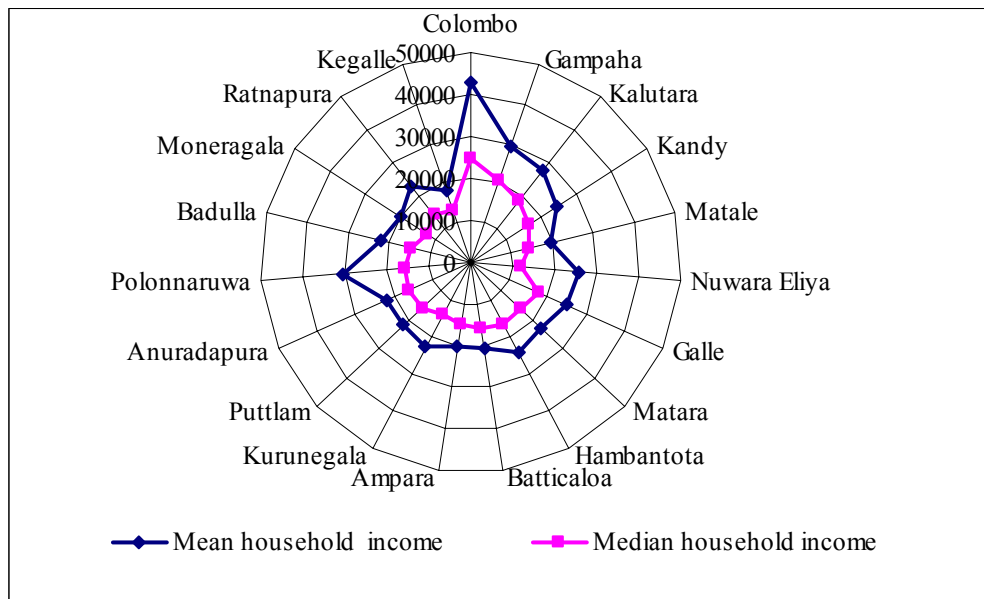


Figure 2.3: Median and mean household income by district – 2006/07

The share of income to total household income shows the similar pattern for decile groups in Sri Lanka as well as in all sectors. For example 10th decile group has recorded the highest share of income to total household income in all sectors. The corresponding figures for urban, rural and estate sectors are 46 percent, 37 percent and 52 percent respectively.

Further it can be seen that the richest 20 percent (9th and 10th group) receives nearly 55 percent of the total income in Sri Lanka while the poorest 20 percent (1st and 2nd group) receives only 5 percent of the total income. When the poorest 40 percent is considered, the corresponding figure is reported as 13 percent for Sri Lanka. (Table 2.4) This pattern remains unchanged for last 20 years period.

Figure 2.4: Share of mean household income to total income – 2006/07

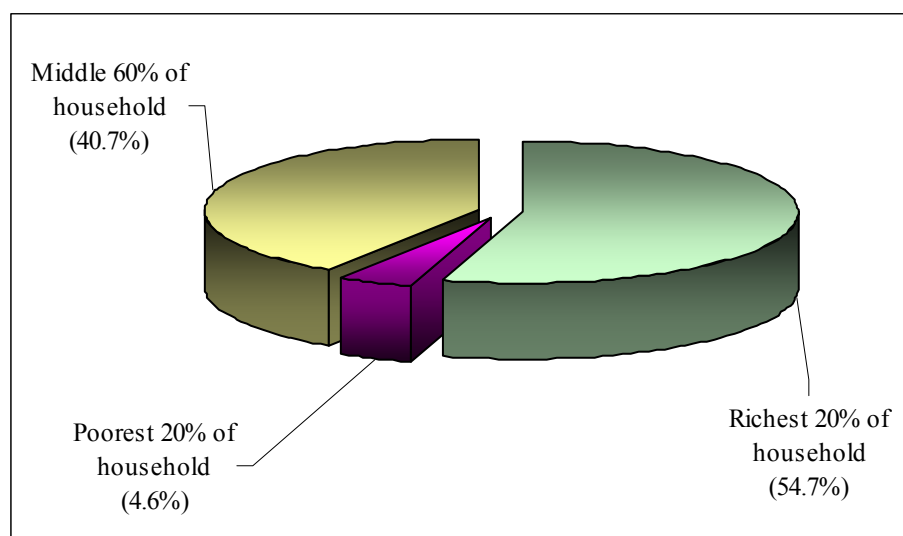
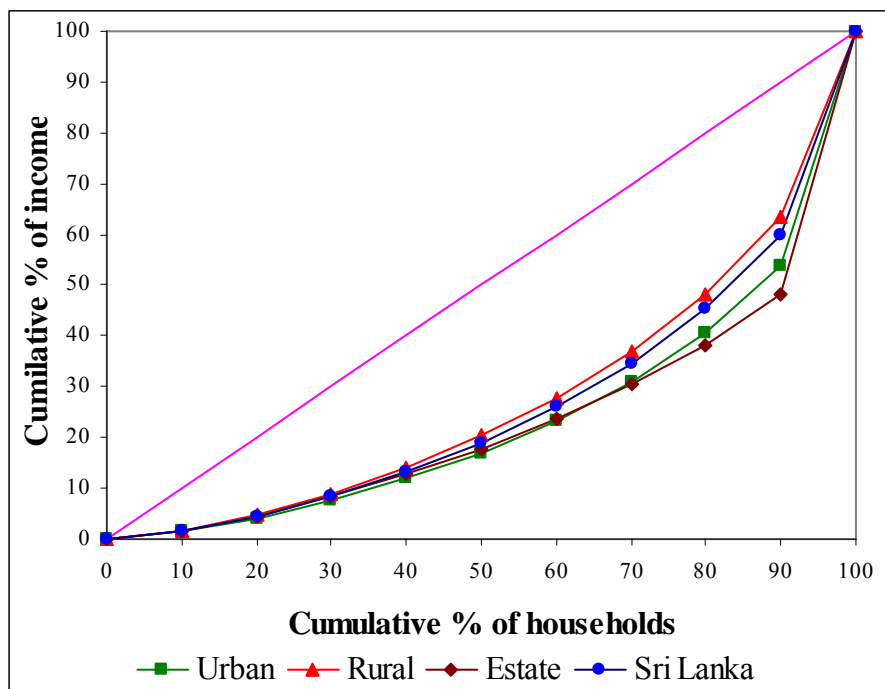

Gini coefficient is one of the most important indicators to measure income inequality of a society. It can take values between zero and one. If the value of Gini coefficient is zero then it indicates the perfect equal distribution of income in that domain. The high extreme values highly influence the Gini coefficient. For the small domains, the extreme values which were reported from estate sector, Nuwara Eliya and Polonnaruwa districts were removed when calculating Gini coefficients In 2006/07 data set. In 2006/07 survey results reveal that Gini coefficient of mean household income is 0.49 in Sri Lanka. Gini coefficient for urban, rural and estate sectors is reported as 0.54, 0.46 and 0.41 respectively. This implies the highest inequality in mean household income distribution is shown in urban sector while the lowest income disparity shows in estate sector. When consider the provinces, western province shows the highest inequality in mean household income distribution and within districts, Colombo reported the highest inequality in mean household income distribution.

2.2 Per capita income

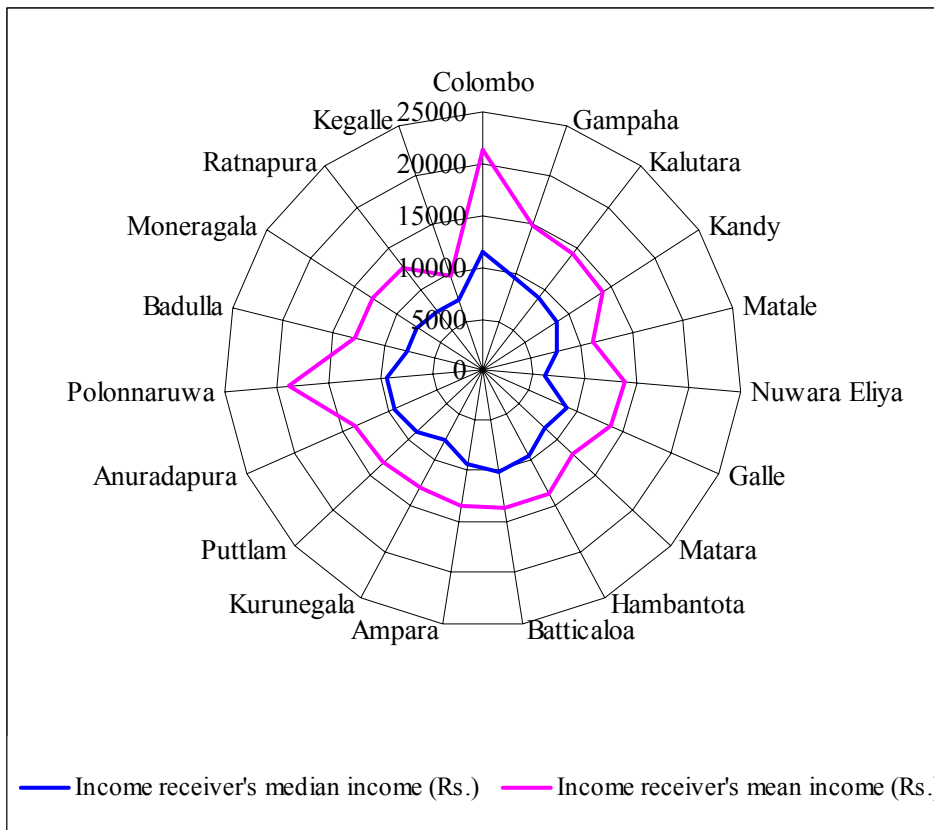
Per capita income usually depends on the household size and the total household income. Per capita income is estimated by dividing the income of all households by the estimated number of household population. Per capita income is also used to measure the wealth of a population of a nation. According to the Table 2.6 mean per capita income is Rs. 6463 per month for Sri Lanka in 2006/07. The median per capita income is reported as Rs. 4043.

The lowest mean number of income receivers is reported from eastern province (1.5) when the provinces are considered. When regarding the districts, Colombo district records the highest mean number of income receivers, which is reported as 2.0.

Table 2.8 shows that the mean number of income receivers /obtainers per household is 1.8 in Sri Lanka. The corresponding figure for estate sector is 2.0, which is reported as the highest among sectors and the corresponding figure for Eastern province 1.5, which is reported as the lowest among provinces. Colombo district is reported 2.0, which is reported as the highest number of income receiver's among districts.

In 2006/07 the average monthly income receiver's income is reported as Rs. 14457 for Sri Lanka. When sectors are compared an income receiver in the urban sector earns almost two times of income than that an income receiver in the estate sector earns for a month. The reported figures for urban sector and estate sector are Rs. 21668 and Rs. 9407 respectively. (Table 2.9) .The lowest income receiver's mean income Rs. 11376, is reported from Sabaragamuwa province among the provinces and Rs. 9761 is reported from Kegalle district as the lowest income receiver's mean income among the districts.

receiver's income decile and mean household income, median household income by household income decile shows the similar patterns in Sri Lanka.

Table 2.11 shows the income receiver's mean income is Rs. 14457 in Sri Lanka. When consider the income receiver's income groups in Sri Lanka, an income receiver's in the lowest decile receive less than Rs.2083, while an income receiver's in the highest decile receives more than Rs. 26250. According to the Table 2.11, it reveals that, the 80 percent of income receiver's in Sri Lanka receive less than the mean income (Rs.26286) in Sri Lanka.

Figure 2.7: Income receiver's median income by income receiver's income group - 2006/07

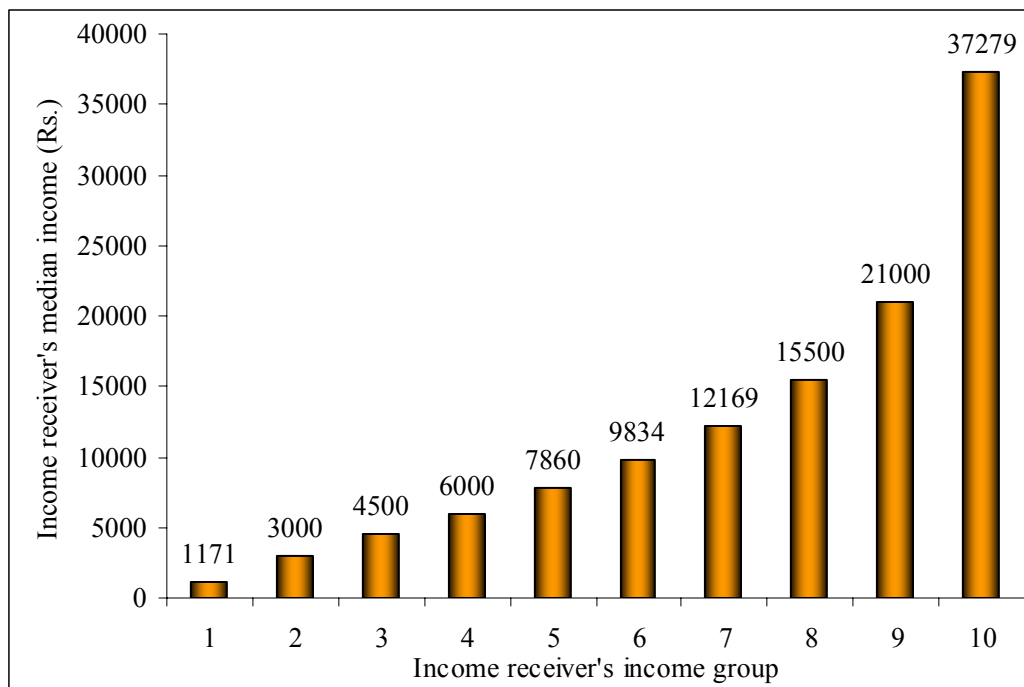

2.4 Source of income

As mentioned earlier, income is received in two main ways, either in cash or in kind. The first is identified as monetary and the second is identified as non monetary. Income from wages and salaries, agricultural activities (seasonal and non seasonal crops), non agricultural activities, and other cash income (which includes pension payments, disability payments, Samurdi, local and foreign transfers, windfall income such as lottery wins, compensations etc.) are identified as monetary income. The non monetary income is the estimated value of good and services received in kind and consumed within the survey reference period. This value is formed by home grown fruits and vegetables, firewood, home consumed quantities of the product of agricultural activities, and other goods or concession values received from employer or other parties. Estimated rental value of owner occupied housing units or freely occupied housing units are also included under non monetary income.

The mean household income per month for Sri Lanka is Rs. 26286 at national level, out of the total household income, Rs. 22616 or 86 percent of the income is received as monetary income in 2007. As usual major part of the monetary income is recorded from wages and salaries and it is about 36 percent of the total household income. (Table 2.13)

3. Expenditure

Household expenditure data were collected in three major groups in the schedule.

- Expenditure on food.
- Expenditure on non food.
- Expenditure incurred by boarders and domestic servants.

Under food expenditure, all the food items consumed by the household during the reference period (one week) were collected. For non food expenditure, all non food items and services purchased by the household during the given reference period were collected. Personal expenditure of boarders and domestic servants who live in the household is reported according to the related expenditure group in a separate section of the schedule.

To obtain more accurate data, the first two sections are divided into 34 sub groups. Of that total 19 sub groups are included under the section of expenditure on food such as cereals, prepared food, vegetables, fish, meat etc. and the rest of 16 sub groups are included under the section of non food expenditure i.e. housing, fuel and light, health, durable goods etc.

To gather more reliable information on expenditure, food expenditure was collected for 7 consecutive days from each household selected in the sample. But non food expenditure was collected for different reference periods varying from one month to twelve months.

3.1 Household expenditure

According to the Table 3.1 the average household expenditure is Rs.22952 per month for Sri Lanka in 2006/07. When residential sectors (Urban, Rural and Estate) are compared, households in urban sector have spent Rs. 35274 per month and households in rural sector have spent Rs. 21440 per month. Households in Estate sector have spent Rs.13456 per month which is the lowest value among sectors.

Table 3.1 also shows the average monthly household expenditure on food and drink, and non food items by province and by district. It is reported that households in Western province have spent Rs. 31437 per month and households in Uva province have spent Rs.15886 per month. When districts are compared the highest mean household expenditure is reported from Colombo district (Rs.37011 per month) while the lowest mean household expenditure is reported from Moneragala district (Rs.13155 per month).

 - 2006/07

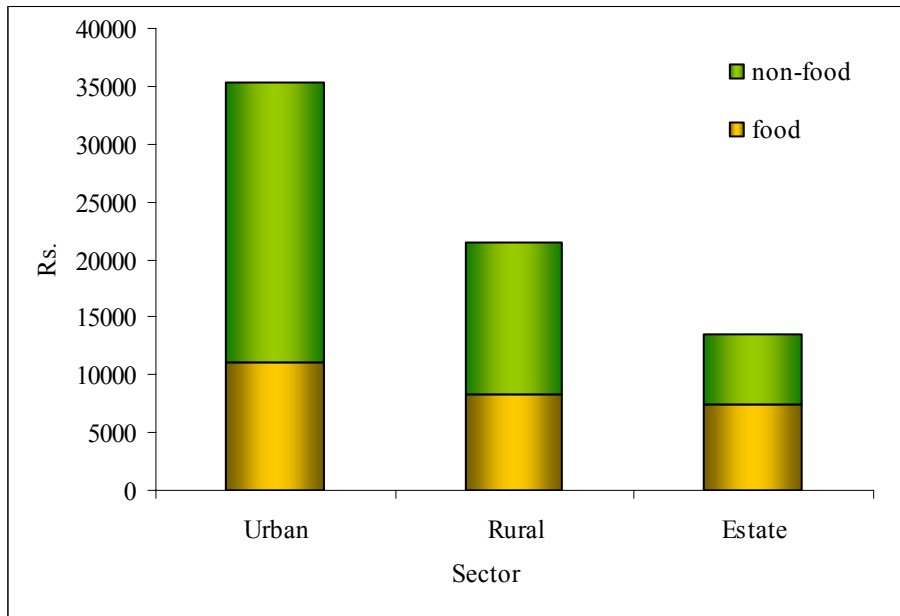
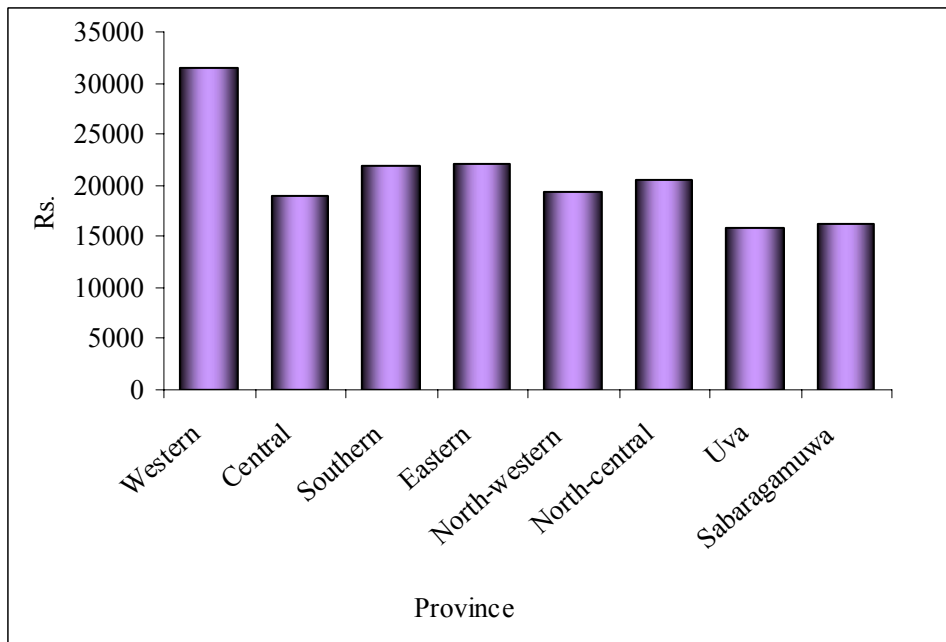


Figure 3.2: Average monthly household expenditure by province - 2006/07



3.2. Food ratio

The ratio of expenditure on food and drink to total expenditure is called the food ratio and it is generally presented as a percentage.

$$\text{Food ratio (\%)} = \frac{\text{Household expenditure on food and drink}}{\text{Total household expenditure (food \& drink and non food)}} \times 100$$

The expenditure on liquor, and tobacco etc. is not considered as a part of food and drink expenditure where as it is a part of the total expenditure in this calculation.

Food ratio indirectly indicates the development of the area with the better living conditions and is also a very useful indicator. Average monthly household expenditure for Sri Lanka is Rs.22952. Of this value, Rs. 8641 is spent on food and drink, which is about 37.6 percent of the total expenditure and it is defined as food ratio.

Table 3.1 shows the food ratio by sector, by province, and by district. When comparing food ratio by districts the lowest food ratio is reported from Colombo district (29.2 percent) while the highest food ratio is reported from Nuwara Eliya district (53.9 percent) in 2006/07. It is clear that those who live in Colombo district spend more on housing, education, transport, electricity, and health etc, compared with those who live in Nuwara Eliya district. This does not imply that the households in Colombo district spend fewer amounts on food than the household in Nuwara Eliya district. The absolute expenditure values for food and drink in Colombo and Nuwara Eliya district are Rs.10795 and Rs. 7665 respectively.

3.2.1 Consumption of food

Cereals (rice, wheat flour, etc.) and prepared food are the two major groups which are consumed in large quantities rather than other major food groups in Sri Lanka. The household consumption and expenditure for major food groups by sector and province and by district are shown in Table 3.3 A and Table 3.3 B.

According to the Table 3.3A when comparing the cereals consumption pattern among the sectors, the highest consumption of cereals is reported from Estate sector (Rs.2234) and the lowest consumption of cereals is reported from urban sector. (Rs.1231) But it is very clear that the households in urban sector have spent more money (Rs.1894) for prepared foods than the households in Rural and Estate sector. The corresponding figures are Rs.919 and Rs.479 respectively.

Table 3.4A and 3.4B shows the percentage distribution of average monthly household expenditure on major food groups given in Table 3.3A and 3.3B respectively. The households in the Nuwara Eliya district have spent 27 percent of total food expenditure on cereal. On the other hand Colombo district shows the highest percentage of expenditure on prepared foods (17 percent of total the food expenditure)

3.2.2 Selected food items

Rice, wheat flour and bread etc. are major food items consumed in Sri Lanka. Table 3.5 shows the expenditure values of some selected food items by national household expenditure deciles. Table 3.6 gives the consumption quantities for those selected food items.

Table 3.5 shows food items like Samba rice, bread, chicken, Kelavalla, eggs, milk powder, banana, etc. the households in the 10th decile group have significantly spent more than households in the first decile group.

Table 3.6 shows the consumption quantities for selected food items like chicken, Kelavalla, and milk powder etc. has increased from first decile to 10th decile when household expenditure deciles are considered.

Figure 3.3: Average monthly household consumption of rice by sector - 2006/07

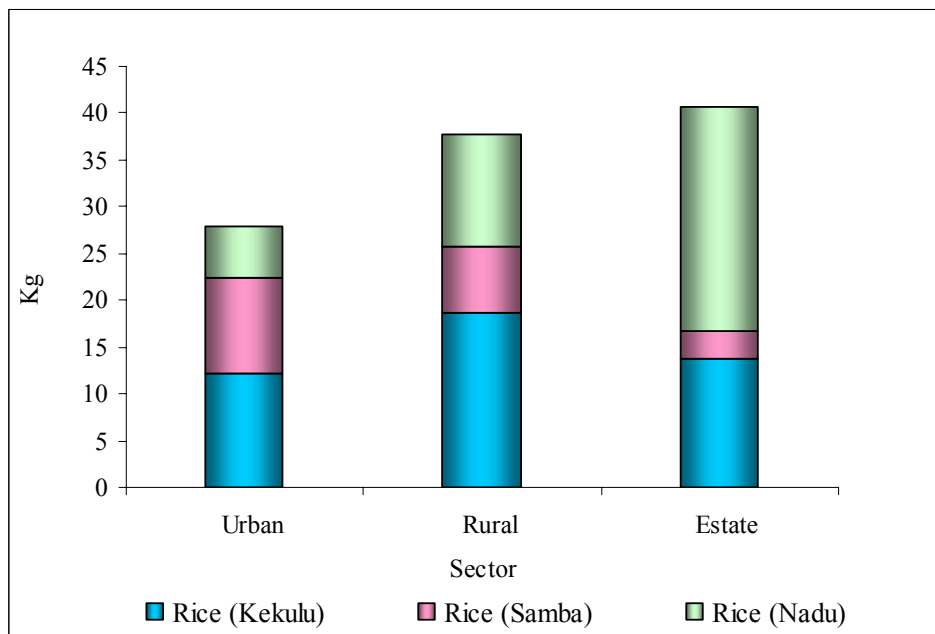

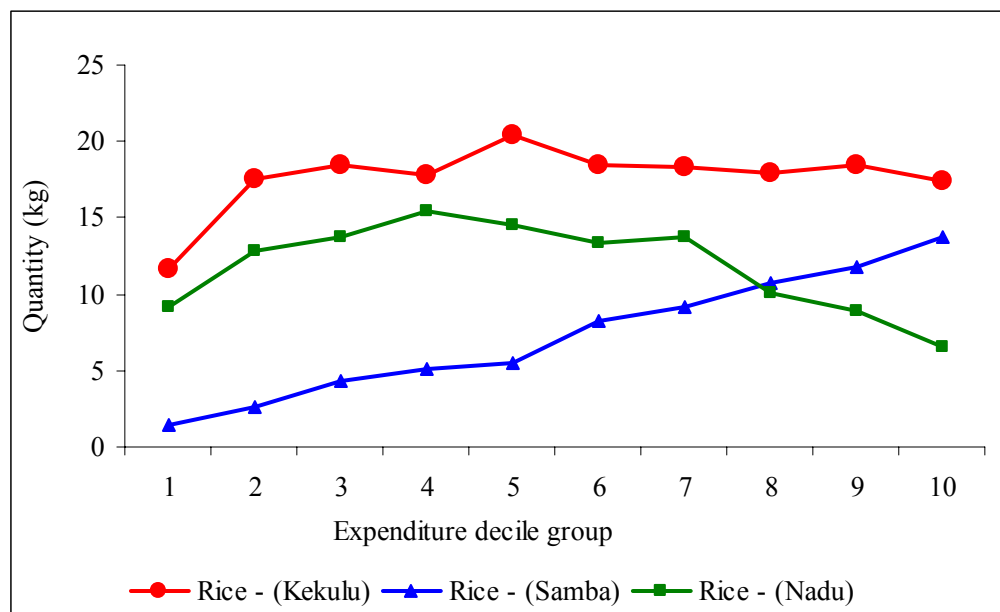

3.2.3 Consumption of rice

When comparing the rice consumption pattern among the sectors, households in rural sector show the highest consumption of Kekulu rice and household in urban sector consume the lowest quantity of Kekulu rice. According to table 3.7A the highest consumption of Nadu rice is reported from estate sector (24kg) and households in urban sector consume the lowest quantity of Nadu rice (5.6kg).

3.2.4 Consumption of wheat flour

The average monthly consumption of wheat flour is reported as 2.4kg per month per household in Sri Lanka. (Table 3.7A)The highest consumption of wheat flour per household per month is reported from Estate sector and Nuwara Eliya district when sectors and districts are compared. It can be notice that the household in Estate sector consume relatively large quantity of wheat flour, which is 10 times higher than that of the other two sectors.

3.2.5 Consumption of bread

Table 3.7A shows that the average monthly household consumption quantities of bread are 6.2kg per month in Sri Lanka. When sectors are compared it can be noticed that the households in urban sector consumed large quantity of bread which is reported as 10.2kg per month.

3.2.6 Consumption of coconuts

Average monthly household consumption of coconuts is 30 nuts per month in Sri Lanka. The households in rural sector consume more coconuts than those in other two sectors. It is reported as 31 nuts per month.

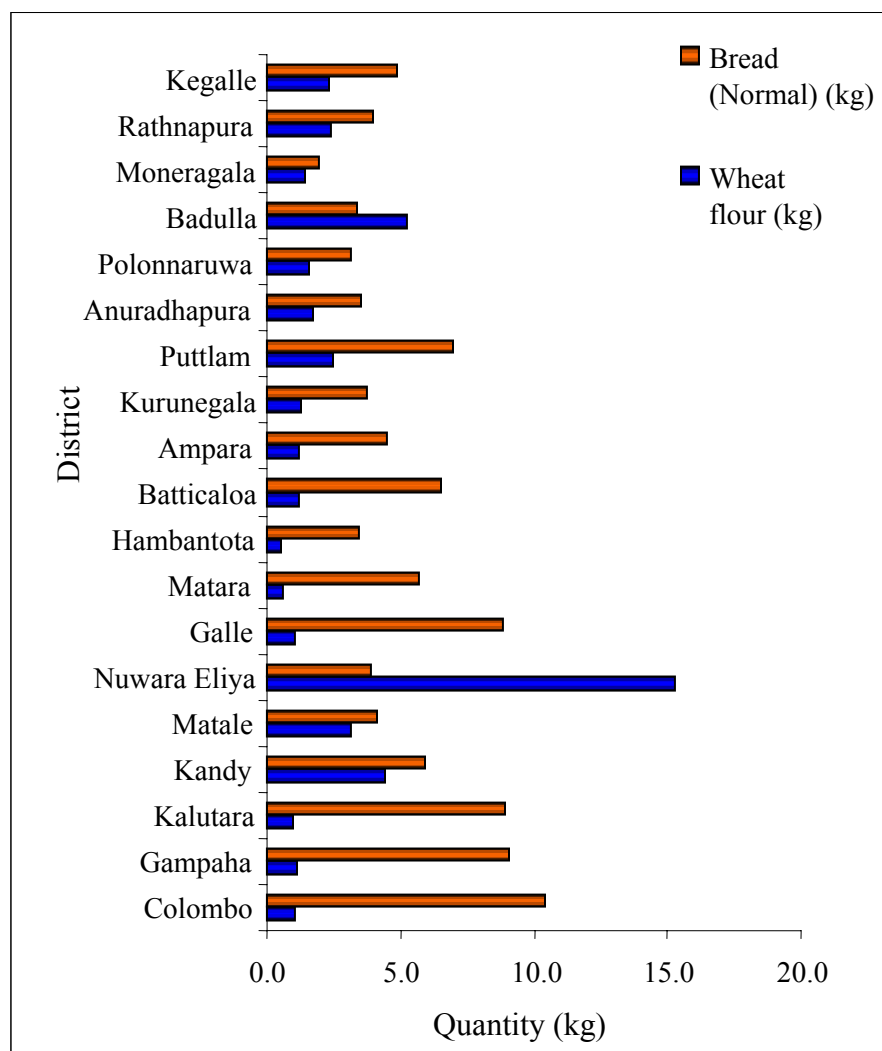

3.3 Non food expenditure

Housing, fuel and light, clothing, health, education, transport, communication etc are the major non food groups in this survey. Table 3.8 and Table 3.9 shows the average monthly household expenditure on major non food expenditure group and their percentage values to total non food expenditure by sector province and district respectively.

According to the Table 3.8 average monthly non food expenditure per household is Rs 14311 (included the expenditure on liquor, tobacco etc.) the lowest total non food expenditure values are reported from Moneragala district and Sabaragamuwa province when districts and provinces are compared. The highest non food expenditure value is reported from urban sector and that value is nearly four times as the non food expenditure in estate sector.

Figure 3.6: Total expenditure on non-food by district - 2006/07

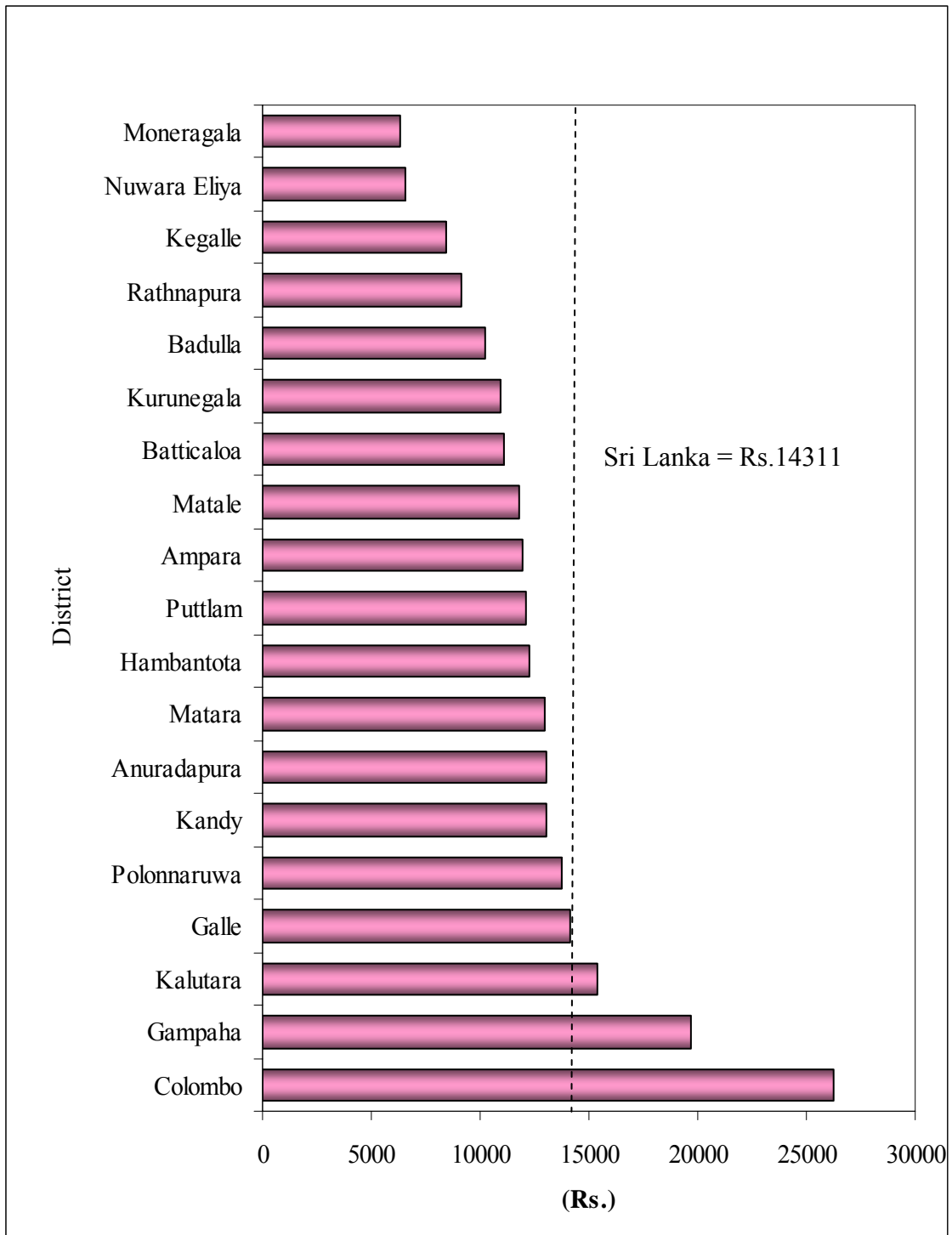


Table 3.10 shows the average monthly household expenditure on major non food expenditure group and by national household expenditure decile. Households in the 1st decile group have spent Rs. 2103 per month for non food items and the corresponding figure for the 10th decile group is Rs.59969. It is very clear a high variation can be observed between the lowest decile group and the highest decile group for expenditure on non food items.

Table 3.12 gives the per capita expenditure value s of the non food expenditure on major groups. When comparing per capita expenditure on non food items; it shows that a person in the 1st decile group has spent Rs.584 per month while a person in the 10th decile group has spent Rs 14865 per month.

Figure 3.7: Average monthly total non-food expenditure by national household expenditure decile - 2006/07

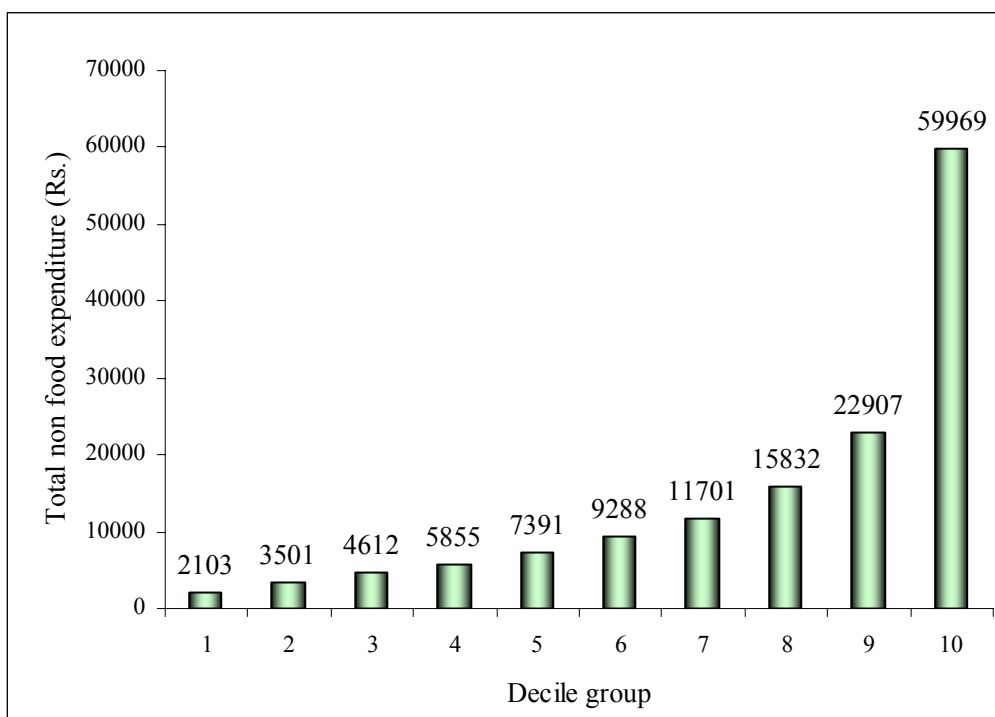

4. Poverty

4.1 Head count index and poverty status

Head count Index is the percentage of population below the poverty line and it is widely used to measure poverty in Sri Lanka.

$$\text{Head Count Index} = \frac{\text{Number of poor people in the population}}{\text{Total population}} \times 100$$

Table 4.1 shows that headcount index is 15.2 percent (percentage of population below the poverty line) at national level.

Estate sector reports the highest head count index (32.0 percent) than that of the other two sectors.

When districts are compared the highest head count index (33.8 percent) is reported from Nuwara Eliya district and the lowest (5.4 percent) is reported from Colombo district.

Table 4.1 also shows the percentage of poor households at sector, province and district level under the poverty definition. According to the Table 4.1, 12.6 percent of households are identified as poor households in Sri Lanka in 2006/07 survey period. The highest percentage of poor households (29.2 percent) is reported from Moneragala district while the lowest percentage is reported from Colombo district as 3.9 percent.

4.2 Poverty Gap Index

Poverty gap index is a better measure to study the depth of poverty and the mean proportionate poverty gap in the population (poverty gap is zero for non poor population)

The following formula is used to compute the poverty gap index. (PGI)

$$PGI = \frac{1}{N} \sum_{i=1}^N \left(\frac{Z - X_i}{Z} \right)$$

Where,

N = Total number of persons

Z = poverty line

X_i = Expenditure of the ith person

X_k = Expenditure for non poor persons

(Z-X_k) = 0; for non poor persons per month

For Table 4.2 shows poverty gap index in year 2006/07 survey period. This is a better measure of poverty. Survey results reveal that the PGI for Sri Lanka is 3.1%. Among the sectors the highest index value (6.2 percent) is reported from Estate sector. Among the districts the highest index value (7.8 percent) is reported from Moneragala district and lowest (1.0 percent) is reported from Colombo district. Squared poverty gap index (SPGI) is also shown in the Table 4.2. It gives the severity of the poverty by giving more weight to the poorest of the poor. SPGI for Sri Lanka is 0.9% for the survey period.

4.3: Dietary Energy Consumption

Table 4.3 shows the average per capita energy consumption for poor households and all households.

The average per capita energy consumption for all households is 2118 kilo calories per person per day in 2006/07 survey period. The corresponding figure for the poor households is 1696 kilo calories per person per day while non poor figure shows 2194 kilo calories.

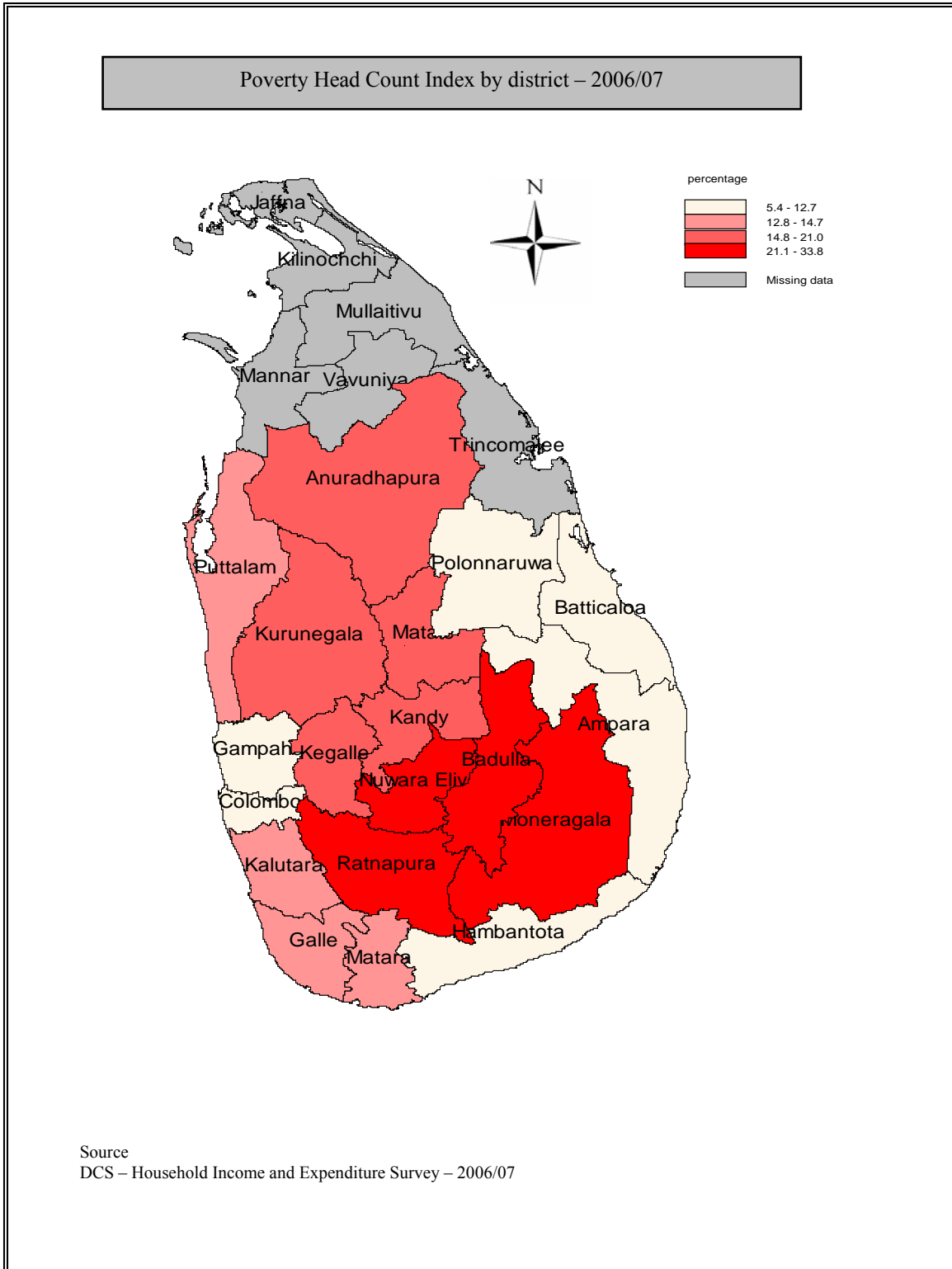
According to the survey results the energy consumption per person per day in urban sector households show a lower value (1316 kilo calories) than the other sectors, when poor households are compared.

Among the districts, Nuwara Eliya, Hambantota and Moneragala districts are at the top of the high dietary energy consumptions and the respective figures are 2383,2309 and 2313 kilo calories per day per capita on average while poor households in Colombo district reported the lowest average per capita energy consumption. (1301 kilo calories) and the poor households in Nuwara Eliya district reported the highest average per capita energy consumption (1962 kilo calories). The next highest average per capita energy consumption reported in Moneragala district (1934 kilo calories).
