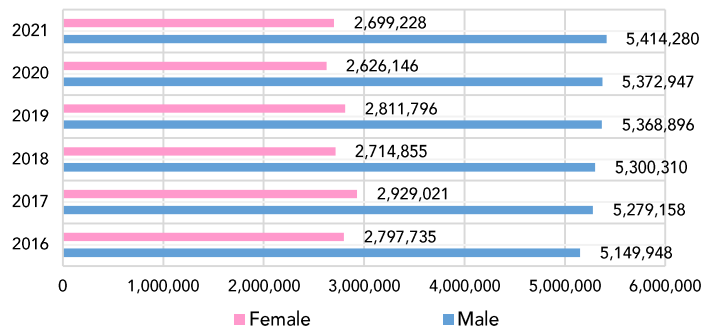

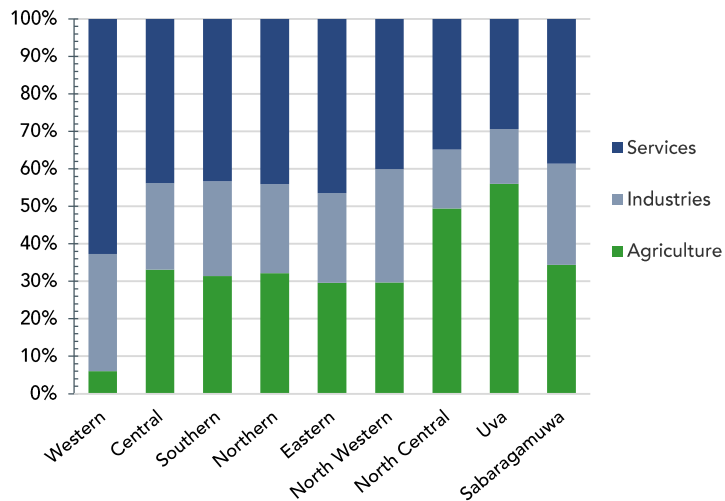

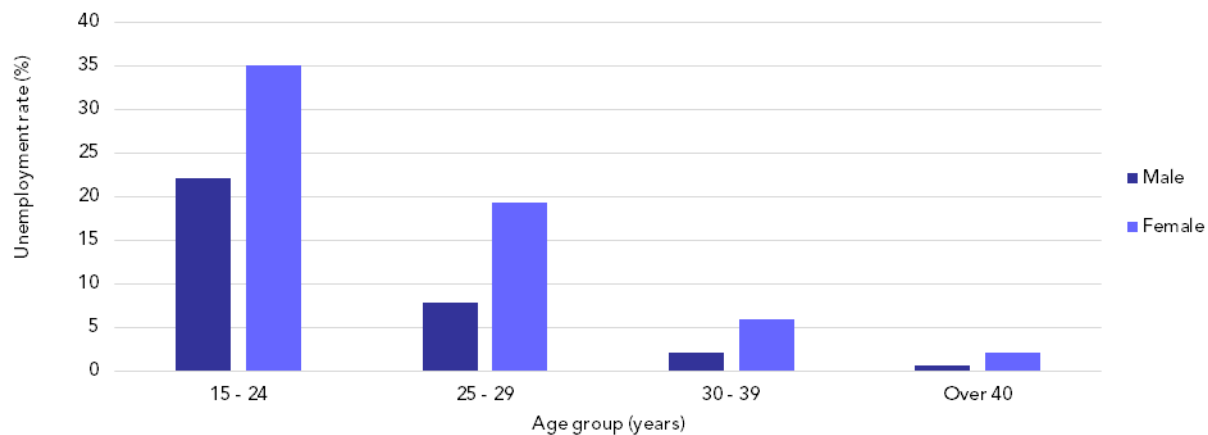

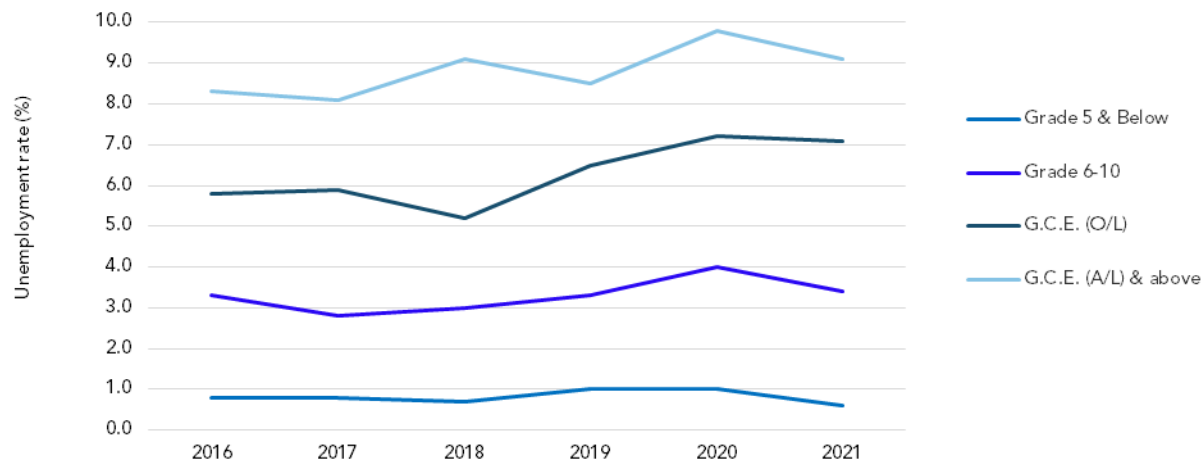

Figure 04 - Unemployment rate by level of education 2016 - 2021

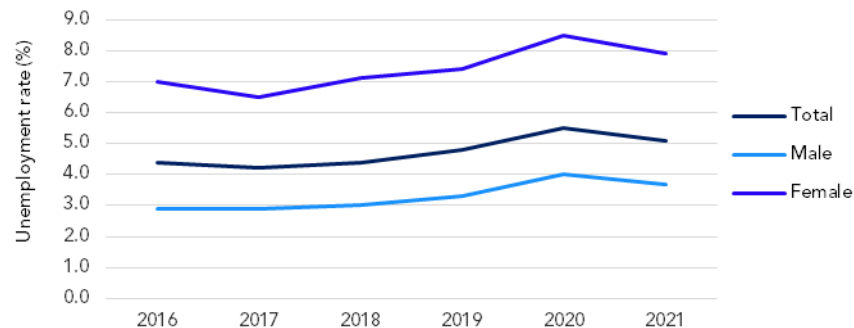

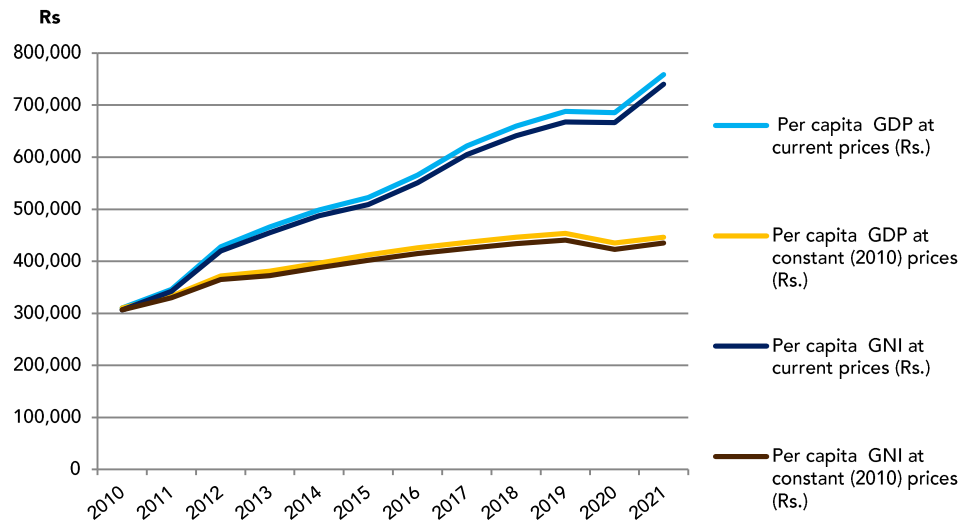

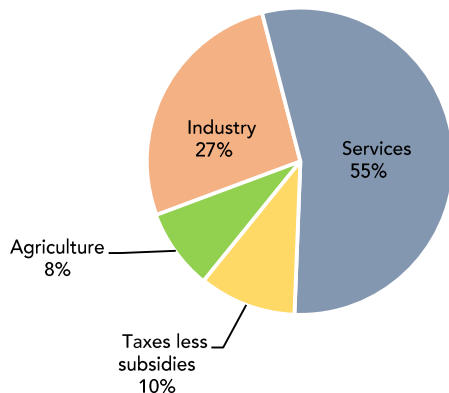

Figure 8 - Presentage share of GDP at current market prices

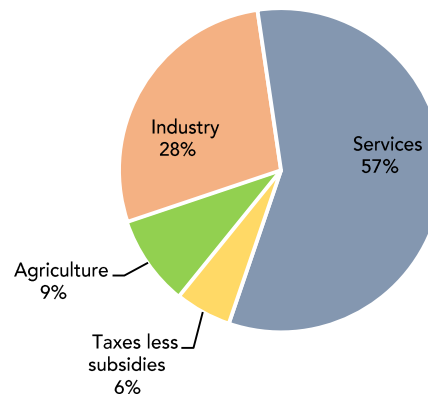
Presentage share of GDP at current market prices - 2010

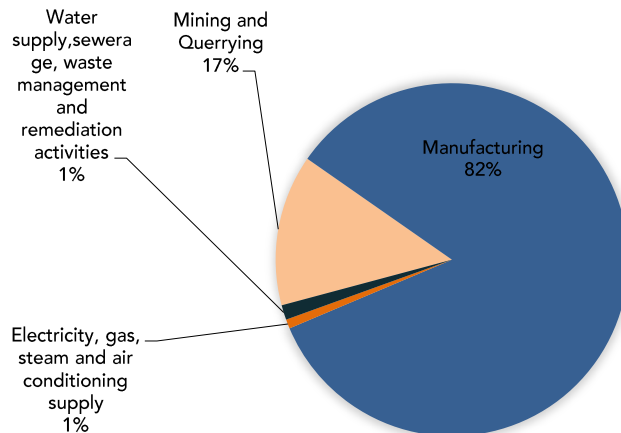

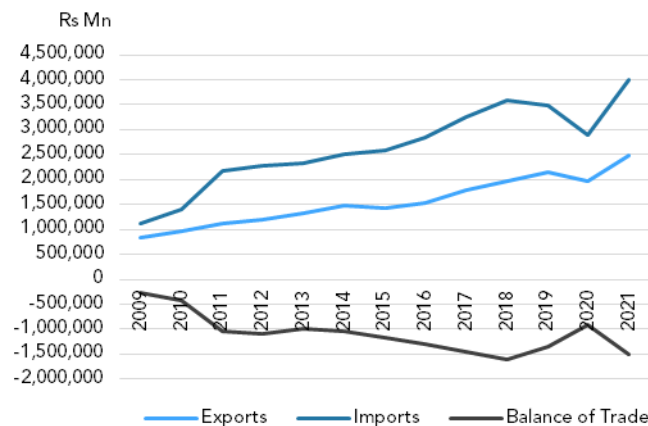

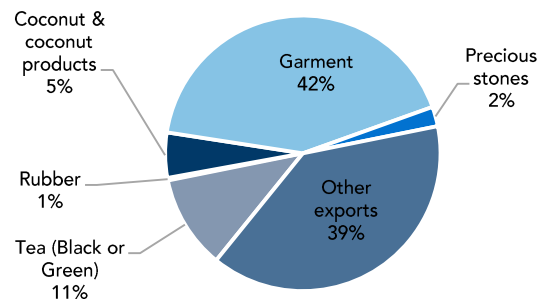

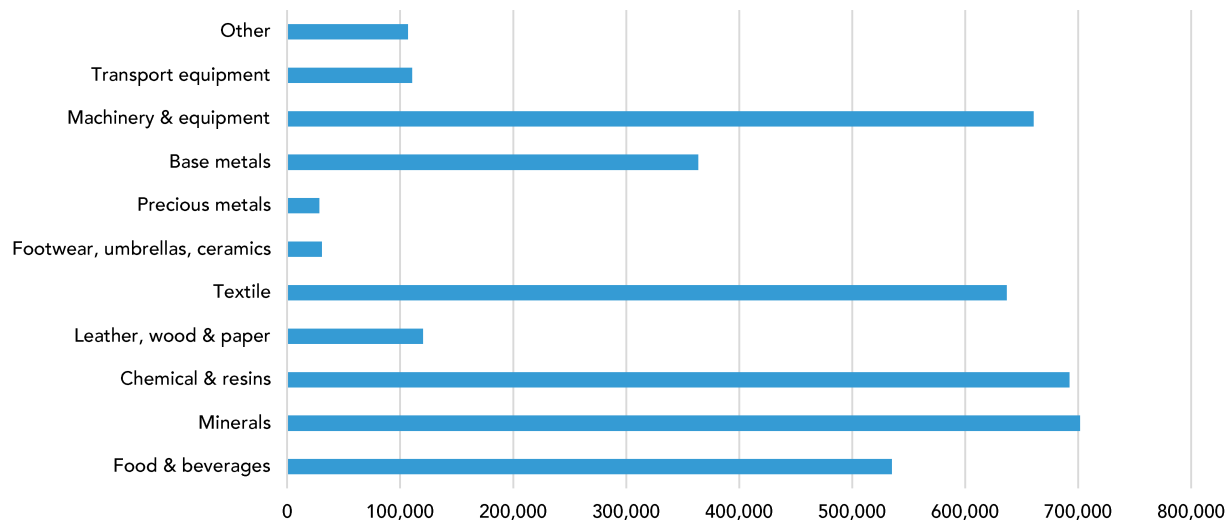

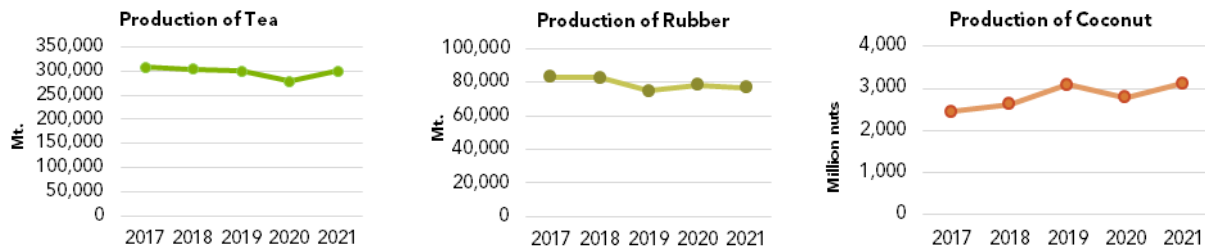

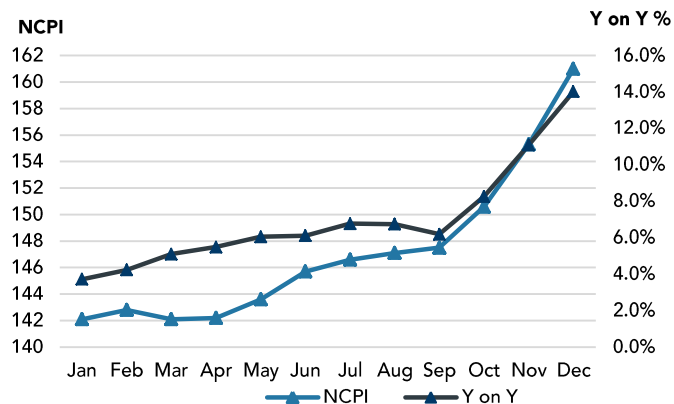

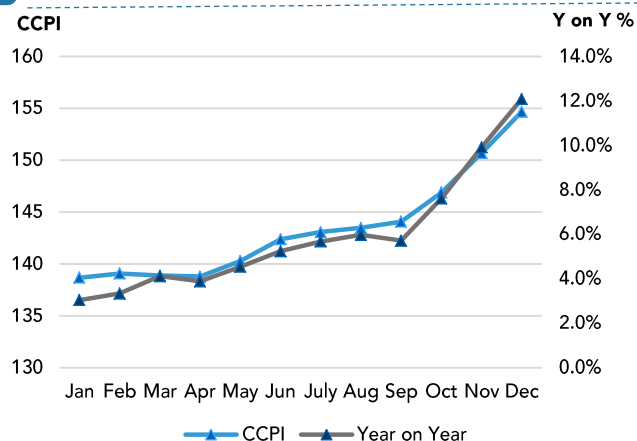

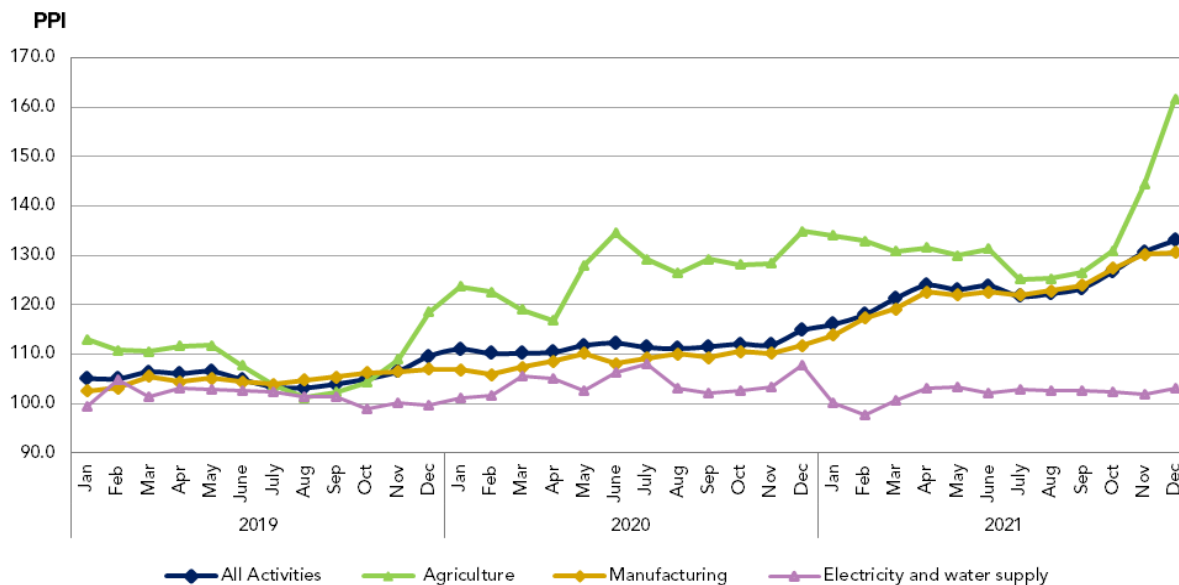
