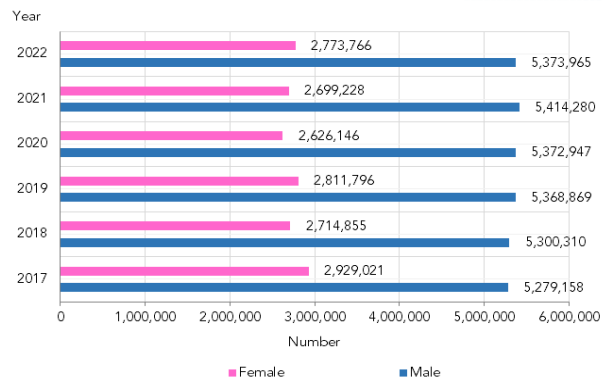

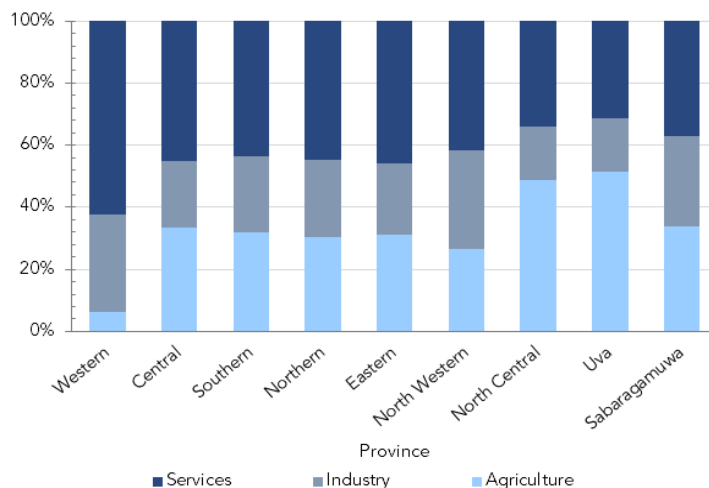

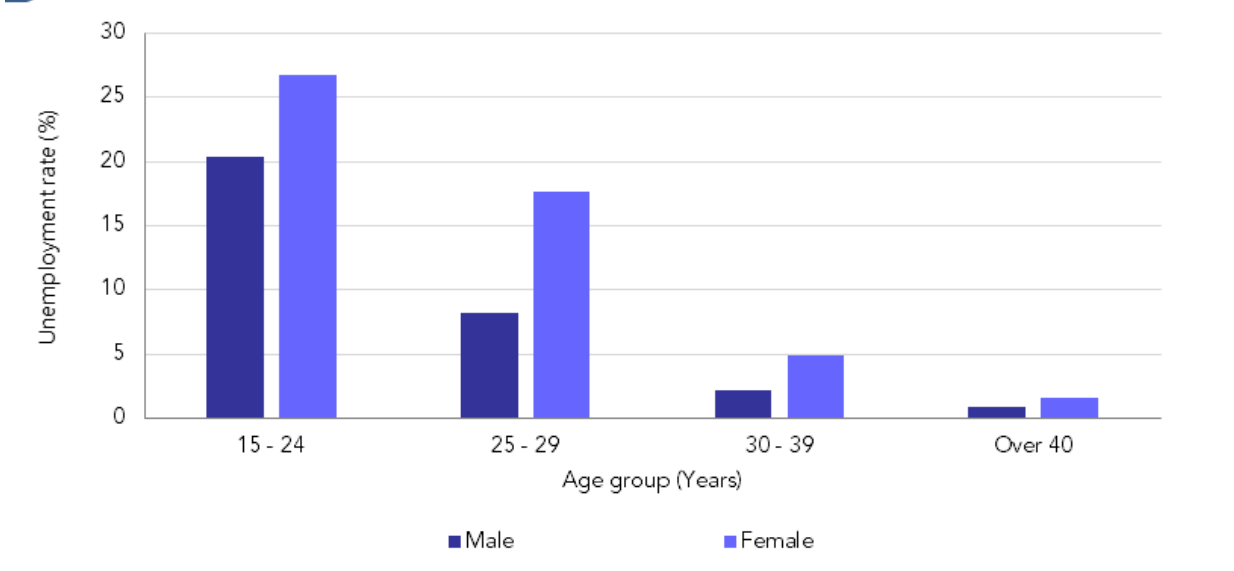

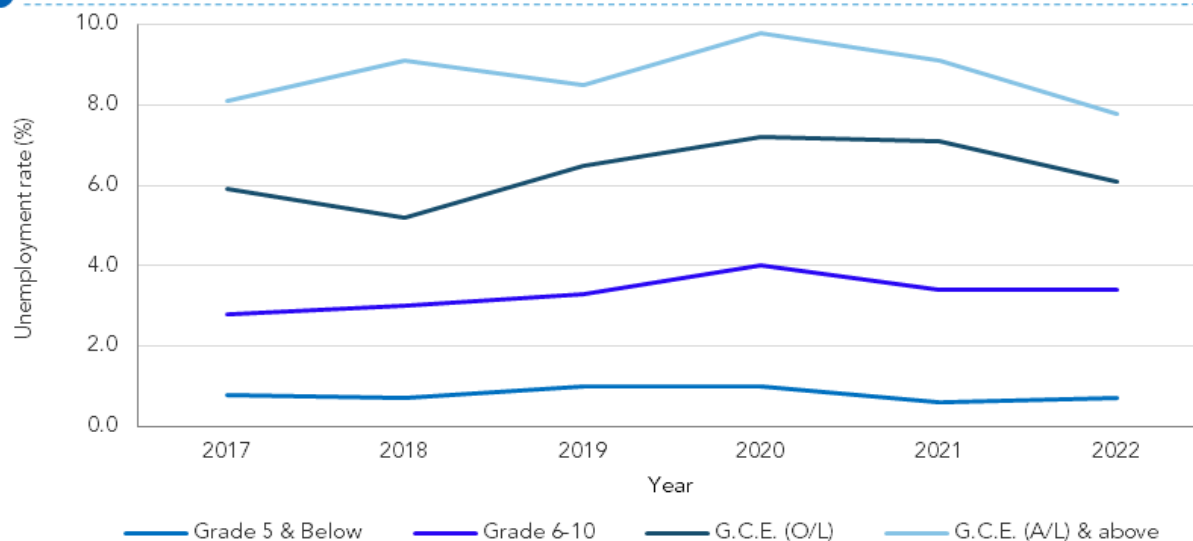

Figure 04 - Unemployment rate by level of education, 2017 - 2022

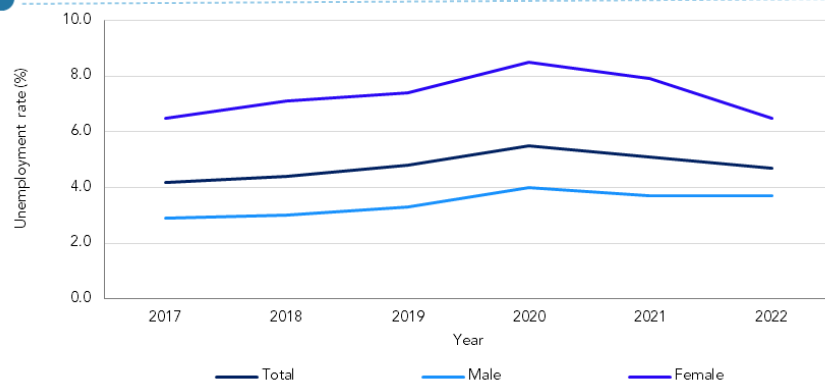

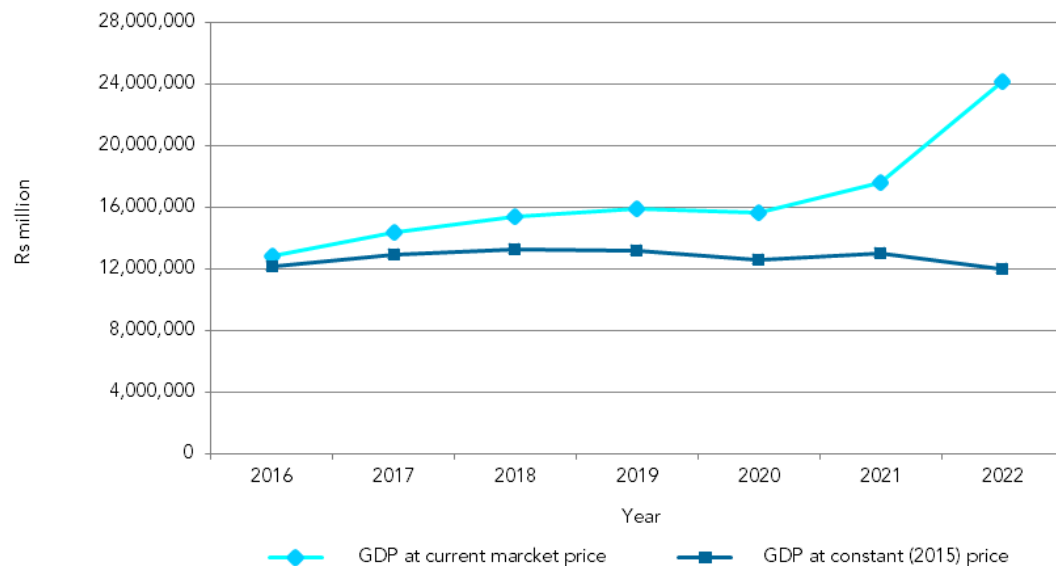

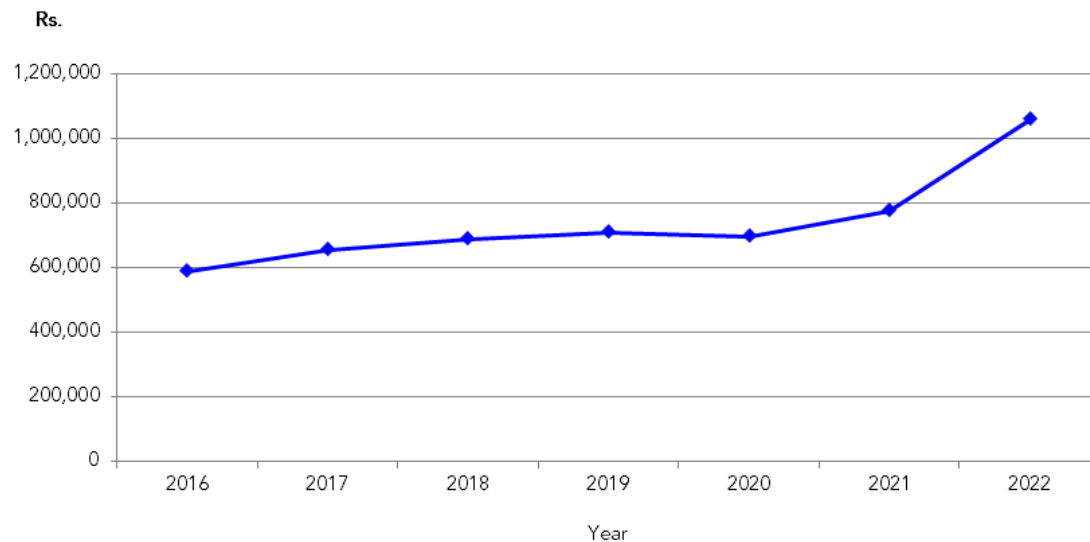

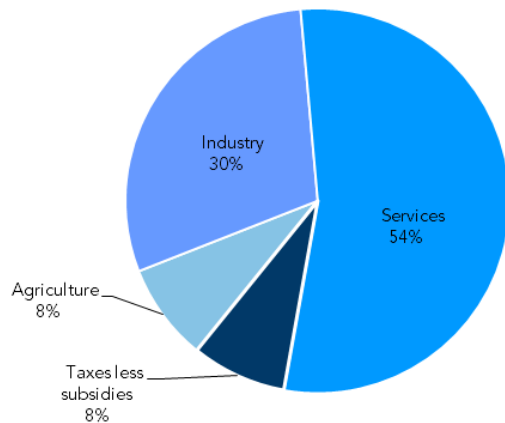

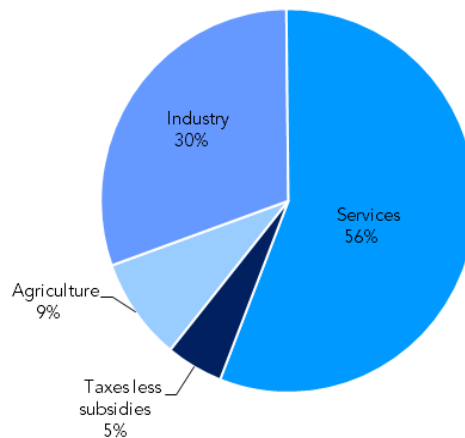

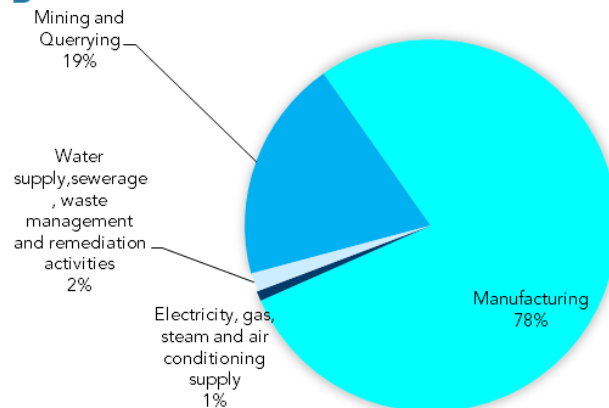

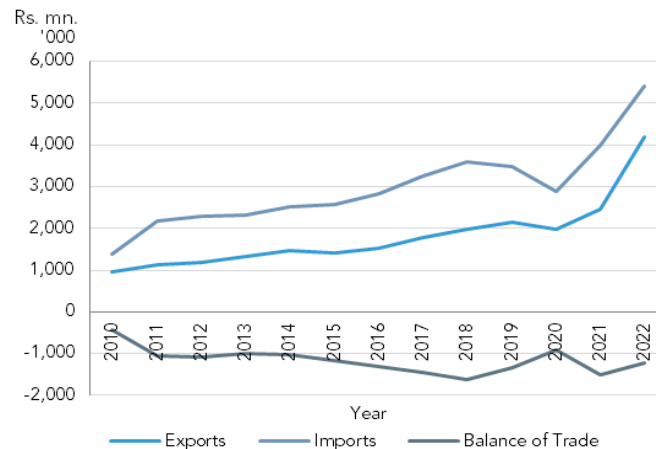

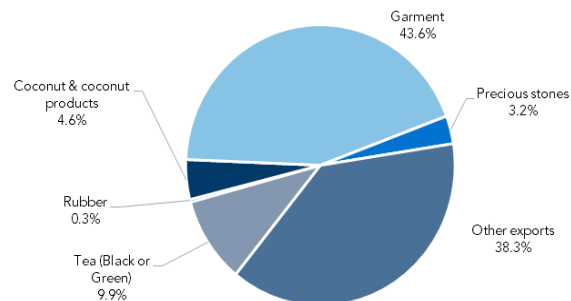

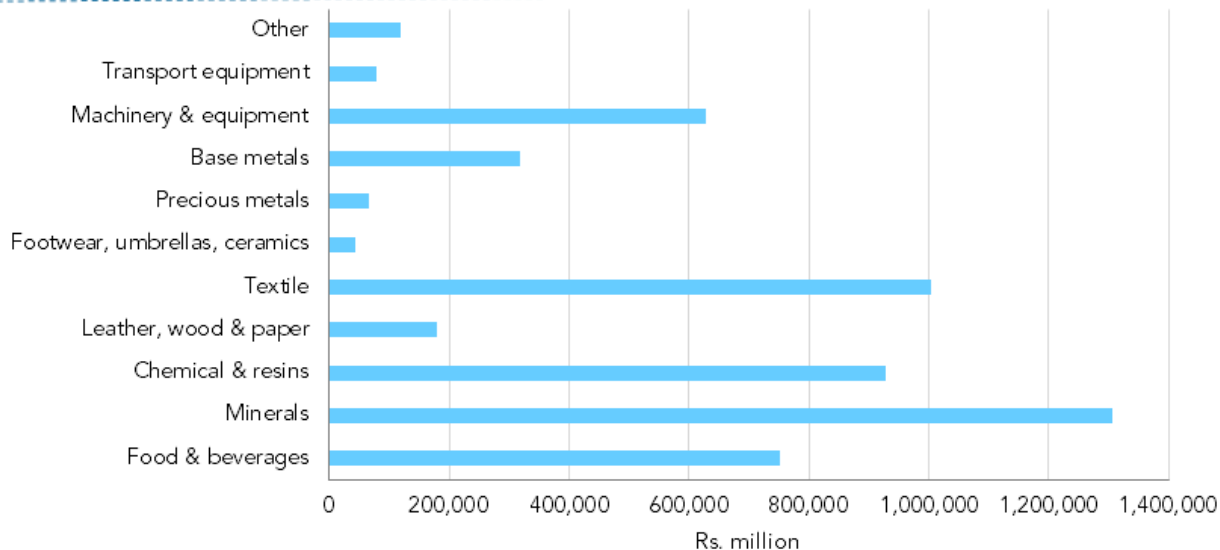

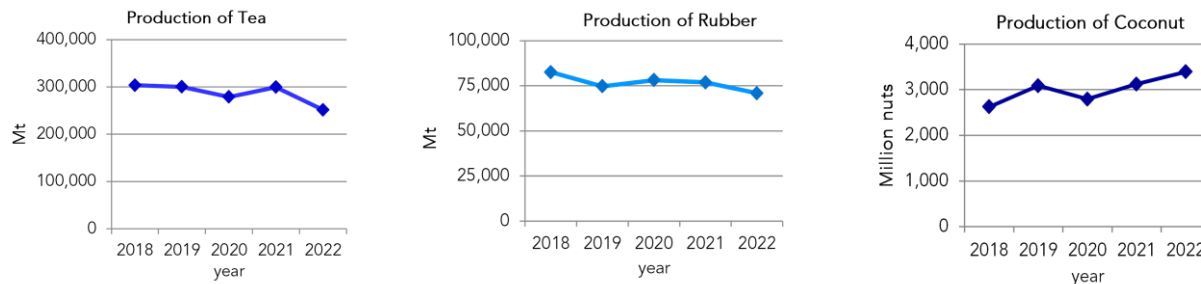

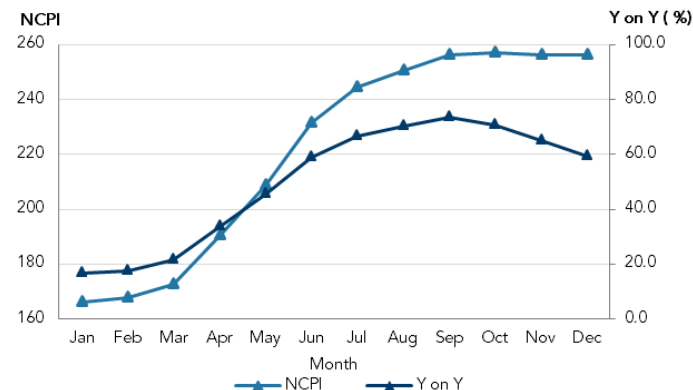

(Base 2013 = 100)



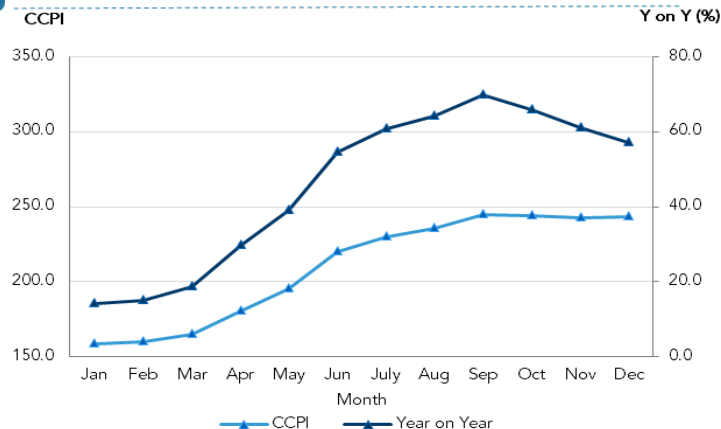

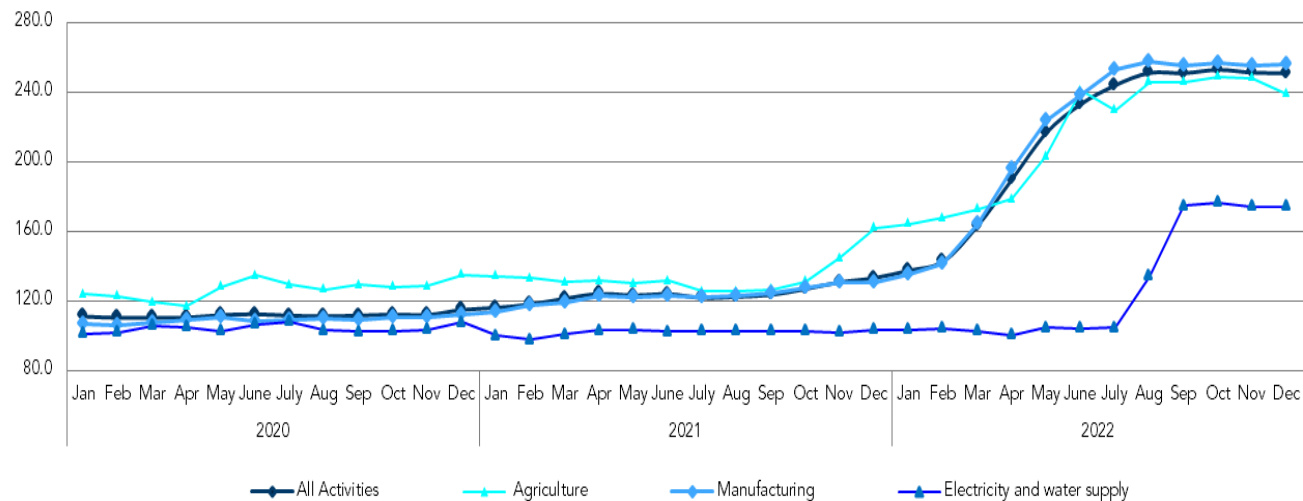
