



NATIONAL CONSUMER PRICE INDEX (NCPI) – (Base 2021=100)

JULY, 2023

The Department of Census and Statistics (DCS) has released the National Consumer Price Index (NCPI) with a new index reference period and Inflation rate for the month of July 2023.

The NCPI with an index reference period 2013=100 was updated to a new index reference period of 2021= 100. The updated NCPI will be released monthly commencing from January 2023 with a time lag of 21 days covering the entire country.

To reflect international recommendations and best practices, the index weights refer to each item's share in the total consumption expenditures of all Sri Lankan households. The provincial weights refer to the consumption expenditures within the province in proportion to the expenditures in the whole country. The index weights are based on expenditure data derived from the HIES conducted in year 2019. The HIES 2019 included all types of consumption expenditures by households, and was broadly representative of all households in the country.

The national consumer basket for the updated NCPI includes 485 items which represent the consumption expenditure of all households in Sri Lanka. For the compilation of NCPI, three price quotations are collected for each of the items in every district town. Prices for some items are collected weekly, while prices for other items are collected once every two weeks, monthly or quarterly. The frequency of price collection is determined by on an average how frequently price changes take place.

- The NCPI (Base 2021=100) for all items for the month of July 2023 is 201.9 and it records a decrease of 1.4 in index points compared to the June 2023.
- The overall rate of inflation as measured by NCPI (Base 2021=100) on Year-on-Year basis is 4.6% in July 2023.

01. Month on Month (M on M) change of NCPI (Base 2021=100):

The NCPI for all items for the month of July 2023 is 201.9. A decrease of 1.4 index points or 0.7 percentage compared to June 2023 for which the index was 203.3. This decrease represents a decrease in expenditure value of Rs. 724.47 in the "Market Basket".

Monthly changes of index numbers, expenditure values and percentage change of index numbers are given in the following table (Table 01).

Note 1: There are 12 main groups of the market basket. Monthly significant changes were noted in eleven main groups in July 2023, details on which are given in Table 02.

Contribution to Month-on-Month Changes:

Contributions to the NCPI on Month-on-Month basis (July 2023 as compared to June 2023) are given in Table 02. The month-on-month change was contributed by decreases in food items and non-food items of 0.17% and 0.53% respectively.

1.1.1. Contribution of Food items: -0.17%

As shown in Table 02, the decreases in index values were reported for Coconuts (0.13%), Vegetables (0.07%), Coconut oil (0.07%), Rice (0.06%), Biscuits (0.04%), Bread (normal) (0.03%), Mysore dhal (0.03%), Milk powder (0.03%), Chili powder (0.03%), Fresh fish (0.02%), Green gram (0.02%), Buns (0.01%), Dried chilies (0.01%), Wheat flour (0.01%), Rice flour (0.01%), Noodles (0.01%) and Turmeric powder (0.01%). However, increases in index values were reported for Green chilies (0.10%), Potatoes (0.04%), Eggs (0.04%), Big onions (0.04%), Fresh fruits (0.04%), Chicken 0.04%), Dried fish (0.03%), Tea dust/leaves (0.03%), Red onions (0.03%), Sugar (0.02%), Garlic (0.02%), Ginger (0.01%) and Canned fish (0.01%).



1.1.2. Contribution of Non-food items: -0.53%

The decreases in index values of non-food groups in July 2023 compared to the previous month was mainly due to the price decreases in groups of items 'Housing, Water, Electricity, Gas and Other fuels' (*Electricity bill and LP Gas*) (1.08%), 'Health' (*Purchase of medical/pharmacy products*) (0.02%), and 'Clothing and Footwear' (*Clothing*) (0.01%). However, price increases in groups of items were reported for 'Alcoholic Beverages, Tobacco and Narcotics' (*Arrack, Cigarettes*) (0.23%), 'Furnishing, Household equipment and Routine household maintenance' (0.02%), 'Transport' (*Petrol*) (0.08%), 'Recreation and Culture' (*Lotteries and Exercise books & stationeries*) (0.10%), 'Education' (*Tuition fees*) (0.11%), 'Restaurants and Hotels' (0.02%) and 'Miscellaneous Goods and Services' (0.01%). Meanwhile, the price index of 'Communication' group remained unchanged during the month.

Inflation

The NCPI is a macroeconomic indicator compiled to measure inflation which is defined as a sustained increase in the general level of prices for goods and services and it is measured as an annual percentage increase by NCPI. Inflation can be measured in two ways. One measure is the Year-on-Year base or Point-to-Point inflation (The percentage change in the current month CPI over same month CPI of last year). The other measure is Moving Average Inflation (The percentage difference between the average Price Indices of last 12 months & the average Price Indices of previous 12 months).

2.1. Year -on-Year Inflation

The overall rate of inflation as measured by the NCPI on a Year-over-Year basis was 4.6% in July 2023 and inflation calculated for the June 2023 was 10.8%. (Table 03). On a monthly basis, the Year-on-Year inflation of the food group decreased to - 2.5% in July 2023 from 2.5% in June 2023 and the Year-on-Year inflation of the non-food group decreased to 10.9% in July 2023 from 18.3% in June 2023.

Contribution to Year-on-Year inflation:

On Year-on-Year basis, contribution of food commodities to inflation was -1.19 percent in July 2023 compared to the month of July 2022 (Table 04).

Contribution of non-food items was 5.75 percent. This was mainly due to price increases in groups of items 'Alcoholic beverages, Tobacco and Narcotics' (0.47%), 'Clothing and Footwear' (0.88%), 'Housing, Water, Electricity, Gas and Other fuels' (2.51%), 'Furnishing, Household equipment and Routine household maintenance' (0.57%), 'Health' (0.56%), 'Communication' 0.30%), 'Recreation and Culture' (0.58%), 'Education' (0.57%), 'Restaurant and Hotels' (0.38%) and 'Miscellaneous goods and services' (0.64%) during the period. However, a decrease in prices for a group of items was reported for the group Transport' (1.70%).


