



# Producer Price Index (PPI) February, 2024

The Producer Price Index (PPI) measures the average change over the time in prices received by domestic producers of goods and services. The introduction of the PPI in Sri Lanka provides a more complete picture of price movements and trends for making informed policy decisions. Department of Census and Statistics (DCS) changed the references of the PPI to 2018 - Q4 in 2021 and disseminate the figures effective from month of November 2021 with 40 days of lag time up to December 2022. From the month of January 2023, the PPI is release with a time lag of 30 days.

PPI is an important macro-economic indicator. It serves as an indicator of short-term inflationary trends and as a deflator of economic series. It is also used in productivity analysis, contract escalation, business analysis and current cost accounting etc. PPI covers the "Agriculture", "Manufacturing" and "Electricity, gas, steam and Air conditioning supply & Water supply" sectors of the economy under the rebased PPI also.

- The PPI for all economic activities: "Agriculture", "Manufacturing" and "Electricity, gas, steam and Air conditioning supply & Water supply" for the month of February 2024 is 247.3.
- On an annual basis, PPI has been compiled as a negative change of 2.1 percent.
- Comparing the month-on-month changes, PPI in February 2024 has increased to 247.3 from 245.9 reported in January 2024.

# Annual Changes of Producer Price Index (PPI)

The PPI for all economic activities: "Agriculture", "Manufacturing" and "Electricity, gas, steam and Air conditioning supply & Water supply" for the month of February 2024 is 247.3. PPI has been compiled as negative change of 2.1 percent on an annual basis. The PPI reported for the three major economic activities, "Agriculture", "Utility Sector" ("Electricity, gas, steam and Air conditioning supply & Water supply") and "Manufacturing" are 274.7, 244.2 and 243.7 respectively. All three major sectors, "Utility Sector" ("Electricity, gas, steam and Air conditioning supply & Water supply") and "Agriculture" reported positive changes of 24.8 percent and 17.7 percent while "Manufacturing" reported a negative change of 5.5 percent on an annual basis (Table 1).

In the Agriculture sector, the sub-activities of "Growing of non-perennial crops", "Animal production" and "Growing of perennial crops" reported positive changes of 29.7 percent, 15.6 percent and 9.9 percent respectively on an annual basis (Table 3).

The sub-activities of the Manufacturing sector: "Manufacture of tobacco products (43.3%)" and "Manufacture of beverages (14.5%)" reported positive changes while "Manufacture of basic metals (23.7%)", "Manufacture of chemicals and chemical products (13.8%)", "Manufacture of textiles (13.1%)", "Manufacture of food products (12.7%)", "Manufacture of furniture (9.9%), "Printing and reproduction of recorded media (9.8%)", "Other manufacturing (8.8%)", "Manufacture of coke and refined petroleum products (7.6%)", "Manufacture of rubber and plastics products (5.1%)", "Manufacture of other non-metallic mineral products (4.8%)", "Manufacture of wearing apparel (3.8%)" and "Manufacture of other transport equipment (0.7%)" reported negative changes in the month of February 2024 compared to the same month of 2023 (Table 3).

For the month of February 2024, both sub-activities of the Utility sector ("Electricity, gas, steam, and Air conditioning supply & Water supply"), "Electricity, gas, steam, and air conditioning supply" and "Water collection, treatment and supply" reported positive changes of 27.6 percent and 7.9 percent respectively on an annual basis (Table3).

# Monthly Changes of Producer Price Index (PPI)

Comparing the month-on-month changes, PPI in February 2024 has increased to 247.3 from 245.9 reported in January 2024. This shows an increase of 1.4 index points or 0.6 percentage compared to January 2024. The economic activities of "Agriculture", "Utility Sector" ("Electricity, gas, steam and air conditioning supply & Water supply") and "Manufacturing" reported positive changes of 1.8 percent, 1.1 percent and 0.4 percent respectively compared to the preceding month (Table 2).

The sub-activities of the "Agriculture" sector, "Growing of perennial crops" and "Animal production" reported positive changes of 18.4 percent, 3.8 percent while "Growing of non-perennial crops" reported a negative change of 12.9 percent on a monthly basis in the month of February 2024 compared to January 2024(Table 3).

In the Manufacturing sector, the sub-activities, "Manufacture of beverages (1.9%)", and "Manufacture of food products (1.8%)" reported positive changes on a monthly basis. "Manufacture of tobacco products", "Manufacture of coke and refined petroleum products", "Manufacture of other non-metallic mineral products" and "Manufacture of basic metals" remained unchanged compared to the preceding month while "Manufacture of other transport equipment (2.3%)", "Other manufacturing (1.7%)", "Manufacture of rubber and plastics products (1.3%), "Manufacture of chemicals and chemical products (0.6%)", "Printing and reproduction of recorded media (0.5%)", "Manufacture of furniture (0.4%)", "Manufacture of textiles (0.3%)" and "Manufacture of wearing apparel (0.2%)" reported negative changes on a monthly basis (Table 3).


The Sub-activities of the Utility sector ("Electricity, gas, steam and Air conditioning supply & Water supply"), "Electricity, gas, steam and Air conditioning supply" and "Water collection, treatment and supply" reported positive changes of 1.2 percent and 0.7 percent on a monthly basis in the month of February 2024 (Table 3).

# **Revision Policy**

PPI is compiled by collecting prices received by the domestic producers 277 manufacturing and utility related establishments. Prices of 42 agricultural products are collected from 331 Divisional Secretariat Divisions covering the entire country. Electricity, gas, steam and Air conditioning supply& Water supplysector prices are collected from Ceylon Electricity Board and National Water Supply & Drainage Board respectively.

In certain circumstances, it is not possible to collect requested prices by the time of releasing PPI. Such prices are therefore, statistically imputed. Therefore, indices of the latest month are released as provisional.

The Producer Price Index (PPI) (Base: 2018Q4=100) was released monthly with a lag of 40 days, with effect from November 2021 to December 2022. Also, the Producer Price Index (PPI) (Base: 2018Q4=100) will be released monthly, commencing with the PPI of January 2023, on the last working day of the following month. Accordingly, the PPI for the month of March 2024 will be released on 30<sup>th</sup> of April 2024.
