The Index of industrial production (IIP) for the month of May 2020 has been released by the Department of Census and Statistics. The index of industrial production has decreased by 25.5% in the month of May 2020 compared to the same month in 2019. IIP reported for the month of May 2020 and 2019 were 79.0 and 106.1 respectively. Food production, manufacture of coke and refined petroleum products and manufacture of basic pharmaceutical products have reported positive growth rates while others report negative growth rates in volume of production in May 2020.

The Index of Industrial Production (IIP) is an abstract number, the magnitude of which represents the status of production in the industrial sector for a given period of time. The IIP describes changes of the volume of goods and services produced over time. Its main purpose is to provide a measure of the short-term changes in the volume of industrial production from the manufacturing sector in the country. The major advantage of the production index compared to other indicators is the combination of fast availability and detailed breakdown of activities.

Index of Industrial Production (IIP) January 2019 - May 2020


