The Index of industrial production (IIP) for the month of February 2021 has been released by the Department of Census and Statistics. The index of industrial production has decreased by 6.0% in the month of February 2021 compared to the same month in 2020. IIP reported for the month of February 2021 and 2020 were 98.0 and 104.2 respectively.

The Index of Industrial Production (IIP) is an abstract number, the magnitude of which represents the status of production in the industrial sector for a given period of time. The IIP describes changes of the volume of goods and services produced over time. Its main purpose is to provide a measure of the short-term changes in the volume of industrial production from the manufacturing sector in the country. The major advantage of the production index compared to other indicators is the combination of fast availability and detailed breakdown of activities.

Index of Industrial Production (IIP) February 2020 - February 2021


